6. The BEE status of the Applicant.

My client is a commercial farmer which operates an extensive egg production, chicken broilers, feed stock facilities, egg packing stores and associated activities on the affected property, and on which affected property are also infrastructure associated with the above business enterprise. It is common cause that my client will suffer loss and damage to its entire business should mining in future take place on the affected property. Noise, air and water pollution will have a serious effect on egg and chicken production.
