Notice is given in terms of Regulation 54 of the Environmental Impact Assessment (EIA) Regulations 2010, under Section 24(5), 24M and 44 of the National Environmental Management Act (Act No 107 of 1998), published in Government Notice No. R. 543 of 2010, and the National Environmental Management: Waste Act (Act No 59 of 2008) and published in Government Notice No. R. 718 of 2009, of intent to carry out the following activity:

The Clovelly Farming Trust proposes to establish a new dairy, and a 650 000m³ dam, and to cultivate an additional 15 ha of virgin veld, on the Farm Clovelly No. 16370, Underberg, KwaZulu-Natal.

The development triggers several Listed Activities published under Government Notice 544, 545 and 546 of NEMA and 718 of the National Environmental Management: Waste Act (59 of 2008), thus a Scoping and Environmental Impact Assessment is required.
