Pasop vir skelm Prokureurs!

Skelm prokureurs – Hoe hulle die man op straat inloop en valslik dagvaar... Ek hoop Jan Publik lees my ondervinding en besef dat daar tóg lig aan die einde van die tunnel is.

Dit is skokkend, dat die publiek, wat oor die algemeen nie hul regte teenoor Prokureurs in die totale omvang besef en/of verstaan nie, uitgebuit en ingeloopt word, omdat sulke professionele en hoog geleerdes misbruik maak van hulle kennis en ons regstelsel.

Die gemiddelde Jan Publik word ook nie vertel, dat sodra jy so 'n 'skuld erkenning' teken, dat jy addisionele rente óók moet opdok.

Ek het dus 'n skriftelike klage daarvoor ingedien, by die Prokureursorde van die Noordwes Provinsie. Ook, om wetlik my deel na te kom, het ek skriftelik 'n aanbod gemaak om my rekening oor die volgende 5 maande af te betaal. Betalings wat ek dadelik begin doen het – en by gehou het.

Ek was dus baie verbaas om na my eerste betaling te hoor by die prokureursfirma dat my betaling nie aanvaarbaar was nie. Maar ek het aanhou betaal.

Nog erger, NA die tweede betaling gemaak was, ontvang ek 'n balju kennisgewing, dat die Prokureur 'n hofaansoek ahangig gemaak het. In die hofdokumentasie word die volle bedrag, wat betaalbaar was, voor ek begin betaal het, geëis. Ek het egter al my bewyse in plek gehad en kon dus die nodige teen-aksie, inhandig by die hof. Ek kon bewys dat die Prokureur 'n leuen gebruik het en misbruik probeer maak het van die eerbare hof.

Die Prokureur het in hof-geliaseerde dokumentasie, beweer dat ek geen betalings of reëlings gemaak het nie, en kommunikasie weier. Dit was nie net vals nie, maar ook nog skandelik en onderduims, as jy in ag neem dat die rekening amper klaar betaal sou wees (soos in my skriftelike aanbod) teen die datum wat die hofaansoek sou voorkom.

Ek glo die gewone man op straat, sal met my saamstem – hierdie Prokureur se optrede, was niks anders as 'n wraakaanval nie. Eerstens omdat ek my nie deur die vroeë eise laat intimideer het nie, maar ook omdat ek die Prokureur se onwettige optrede aangemeld het. Die kapitale bedrag is intussen klaar betaal, net nie die rente nie, tot die Prokureursorde, 'n besissing daarvoor gemaak het, en dissipliner opgetree het. (Vir addisionele hulp, het ek ook die geval na Carte Blanche verwys.)

'n Kriminele saak van meened (die aflê van 'n valse verklaring onder eed) is nou opgemaak teen die Prokureur, by die plaaslike Polisie. Elke bewys, bankbetaling, kommunikasie ens is ingehandig as deel van my saak. Ek beroep my nou op die regstelsel, die plaaslike Polisie en hof, om my by te staan. Geregtigheid moet seëvier.

Dit is 'n skreiende skande, dat professionele mense, mense van hoë aansien en geleerdheid, so openlik probeer misbruik maak van die howe, om die gewone man op straat te bevak. Ek stel voor dat mense wat rekeninge ontvang, dit noukeurig nagaan, selfs so ver as twee jaar terug en meer. As dieselfde met julle gebeur het, eis dadelik julle geld terug en stel klages in. Skriftelik. Hou bewyse van alles. Dit is al hoe ons dit sal stop.
