The Department of Economic Development, Environment and Tourism ("the Department") hereby provides comments for the consultative Basic Assessment Report (BAR) received on 4 February 2021.

1. **GEO-TECHNICAL REPORT**

The Department advice the involvement of a geotechnical specialist to compile a report that inter a) alia assess the proposed development against the geo-technical characteristics on site, soil forms. soil profile, presence of problem soils, shallow water table and geotechnical constrains. Kindly submit the said report as per the commitment made during the consultation phase with the Department.

2. **CHANGE OF LAND-USE**

The Musina local municipality must be engaged regarding application for rezoning in terms of a) Musina Land Use Management Scheme 2010.

3. ENGINEERING SERVICE REPORT

The Department request for an engineering service report that details out how the developer will a) address the required bulk services for the proposed development i.e. sewage, solid waste, water and electricity. The report should reflect the required demand for the proposed development and envisaged means of supply for such services.

4. PUBLIC PARTICIPATION PROCESS (PPP)

- a) A PPP must be done in accordance to Chapter 6 of the EIA Regulation 2014.
- b) A register for all Interested and Affected Parties must be established and appended to the report. I & Aps should not be limited to the following, South African Heritage Resources Agency, Department of Water and Sanitation, SANparks, Musina local municipality, Vhembe district
- c) Proof of placement of site notice must be provided, by means of a clear and legible image.

5. SPECIALIST DECLARATION FORM

a) The Department request for submission of the specialist declaration forms from each of the specialist involved in the compilation of the BAR.

6. FLOODLINE DETERMINATION

a) Kindly determine whether the preferred site falls within a 1:50 year flood zone. It has been note that according the specialist, the site falls outside the 1:100 year flood zone.

7. BAR COPIES

a) Please note you have until the 8th of March 2021 to submit BAR for decision. Please provide one (1) hard copies and one (1) soft copy of the BAR upon submission.

8. ENVIRONMENTAL MANAGEMENT PROGRAMME

- a) The Department request for the amendment of the Environmental Management Programme to align each activity to be undertaken during various phases (Construction, Operation and Decommission) of the proposed development with the respective biophysical and socio-economic aspects of the environment (i.e. land, water, air, social, economic) that will be impacted upon. Furthermore, the impact rating, mitigation measure and responsible person to implement mitigation measure must be incorporated.
- b) In addition to the above, please address waste generation (general & hazardous), ablution facilities, handling of hazardous substances, alien and invasive plant species, construction camp management, excavation and awareness on construction personnel.

c) During the amendment of the EMPr, more effort must be made to construction phase. Kindly ensure that all the requirements provided in appendix 4 of the EIA Regulation 2014 are addressed.
