**A peach led to fame and fortune**

January is the time to enjoy a Neethling peach. This delicious juicy cultivar was cultivated on the Neethling in the Prince Albert district in the late 1800s by Pieter Kuiper Neethling, states historian Ailsa Tudhope.

He arrived in 1876 and on learning that deciduous fruit had been grown in this area since the 1760's, decided to concentrate on the Neethling. It was an instant winner. This cultivar, which is still grown in the area, has a good yellow colour, excellent flavour and firm texture.

In addition to farming Pieter ran a general dealer business, called Alport, for Canadian immigrant Percy Alport, brother-in-law of Sir John Charles Molteno, first Premier of the Cape. Percy had a general dealer and other businesses in Beaufort West and he also owned the wool washing plant at Klarstroom.

In 1901 Pieter helped establish the Prince Albert municipality and served as the first mayor. It is said that when Pieter died at 10:00 on October 10, 1937, at the age of 90. the Dutch Reformed Church clock stopped.
