Applicant: EThekwini Municipality Water & Sanitation (EWS).

Proposed Development: EThekwini Water & Sanitation (EWS) have been awarded a Record of Decision (RoD) from the Department of Agriculture, Environmental Affairs and Rural Development (DAEARD) to undertake the construction of the Northern Aqueduct (NA) from Emachobeni to Umhlanga, supplying areas in northern Durban with gravity-fed potable water. A new pipeline link to the NA is now being proposed between the existing bulk water distribution system and Phase 1 of the NA project. This pipeline will form Phase 4 of the NA project and is required to be commissioned at the same time as NA Phase1, i.e. 2014. Once completed, Phase 1 of the NAA will provide an important link between the existing distribution system and new developments in the north. The existing system however is presently operating close to its maximum capacity and does not have spare capacity to supply these developments. The most severe bottleneck in the existing system occurs in the section of trunk mains between Duffs Road and Phoenix 2 Reservoir (linking the existing system to the NA Phase1). As a result of this bottleneck, a new link is currently being proposed between Duffs Road and Phoenix 2 Reservoir (NA Ph 4) so that Cornubia and other developments north of Durban can be provided with water within the next 18 months. Phase 4 consists of a 1.2m diameter pipe which is to be laid in parallel with the existing trunk mains between Duffs Road and Phoenix 2.

The large volume of water being transferred requires that a full EIA be undertaken, but permission to undertake a Basic Environmental Assessment has been obtained from the DAEARD.
