in their junior welterweight ABU title fight. We are disappointed about losing the African Boxing Union title to Marcus, but I

could not have asked more from my fighter. 'Sbonlelo threw the kitchen sink at his opponent, but unfortunately his best was not good enough on the day.

'We will view this fight as a learning experience going forward and will definitely make some changes heading into his next assignment,' said Mngomezulu.

The biggest disappointment for the coach was, of course, Tholumusa Ngema's defeat by a 9th round TKO against Jozi's Thato
