Re: Motivation for Changes at DSC (Dermatology and Skincare Centre).

Formerly Kingsleigh Lodge.

The name has been changed as per letterhead, for operational reasons as per consent from the municipality. The building is now used as a SKIN SPECIALIST, DERMATOLOGY AND SKIN CANCER CENTRE.

1: Generator: Operations are conducted daily for skin cancer removals, Power outages and interruptions will result in power operated surgical instruments being non-functional and this will result in failed operations. This is an internationally recognized facility, and we attend to patients referred from Africa and the surrounding islands. We cannot postpone operations due to power failures because these patients are booked and expect to take a flight after the operation. We store skin samples in 8 fridges. We cannot allow these specimens to rot if there is a power failure. Blood samples are also taken and stored in fridges. We cannot interrupt the cold chain. The cold chain is also maintained for medications that need cold storage. The generator is housed in a locked container to prevent rain damage and theft, as a compulsory addition as per the generator specialist.

- 2. Change of room spaces and infrastructure: The changes to plans have been made to accommodate for more space for patient treatment and storage of medications.
- 3. Awnings, shadecloths: Provided for covered secure parking for doctors and staff.
- 4. Removal of wall in front waiting area, To provide for more spacious waiting area, to prevent congestion as the practice became busier.
- Showers installed: For staff cleansing and change areas.
- 6. Conversion of some rooms spaces:

To provide for more private theatre spaces to do minor operations, and spaces for special laser machines.

Please note that this facility is constantly changing, advancing and growing. We have to change our infrastructure to accommodate for progressive methods and ideas.
