AMENDMENT OF AN ENVIRONMENTAL AUTHORISATION FOR THE PROPOSED CONSTRUCTION OF A 66 KV TRANSMISSION LINE FOR THE PROPOSED AGGENEYS SOLAR PHOTOVOLAIC POWER PLANT NEAR AGGENEYS, IN THE NORTHERN CAPE PROVINCE

DEA Reference Number:14/12/16/3/3/1/537 and NEAS Number: DEA/EIA/0001134/2012

Dear Interested and Affected Party (I&AP)

Orlight SA (Pty) Ltd (Orlight SA) was granted an environmental authorisation for the proposed construction of a 66 Kilo Volts (kV) transmission line in Aggeneys, Northern Cape Province on **30 October 2012**. The environmental authorisation, however, had a few typographical errors as it was previously indicated on the I&AP notification letter dated **31 October 2012**. The Department of Environmental Affairs (DEA) has subsequently issued an amended environmental authorisation on **2 January 2013** (please refer to the attached letter), which deals with the errors made in the original authorisation.

In terms of Chapter 7 of the EIA Regulations, a notice of intention to appeal against the decision must be lodged within twenty (20) days (**29 January 2013**) of being notified of the decision. Should any I&AP intend to appeal they are required to provide Orlight SA, through Digby Wells Environmental and DEA with a copy of the notice of intention to appeal. Further to the aforementioned regulation, regulation 62(1) states that "an appeal as contemplated in regulation 61(1) must be submitted within 30 days after the lapsing of the 20 days contemplated in 60(1)."
