**Date of Decision: 24 October 2019**

**Decision:** The Department: Environmental Affairs (DEA) has **granted the 4<sup>th</sup> Amendment to the Environmental Authorisation (EA) dated 12 June 2014** for the 140MW Wind Energy facility with bulk

infrastructure on Koeris Farm (Farm No 78, Portion 1) and Farm Kangnas (Farm No 77, Portion 3) near Sprinbok, Northern Cape Province.

**Reasons for decision:** Please refer to the attached Amendment to the EA for the DEA's reasons for their decision.

**Right to appeal:** You are hereby notified to your right to lodge an appeal against the decision in terms of the National Appeals Regulations, 2014.
