Subject: Response to SKA requirements for RFI testing and mitigation measures.

Mulilo Renewable Project Developments (PTY) LTD (Mulilo), acting as the developer and parent company of the proposed holders of the Environmental Authorisation (EA) of Klipgats Solar PV6 (PTY) LTD, Hoekplaas Solar PV2 (PTY) LTD, Hoekplaas Solar PV3 (PTY) LTD, Hoekplaas Solar PV5 (PTY) LTD and Hoekplaas Solar PV10 (PTY) LTD confirms receipt of the letter from SKA office and appreciated their feedback on the solar projects near Copperton Northern Cape of South Africa.

The Letter from the SKA office requests Mulilo to do the following:

“Prior to construction taking place, appropriate Electromagnetic Interference (EMI) studies will be conducted by Mulilo Renewable Project Developments (or appropriate third parties engaged with by Mulilo Renewable Project Developments) to the satisfaction of the SKA Project Office in order to mitigate all risk of Electromagnetic Interference on the SKA. The mitigation of all risk associated with radio frequency interference on the SKA must be confirmed by measurement following construction to the satisfaction of the SKA Office. Should the risk of radio interference still exist, based on measurements, further mitigation methods must be implemented to remove outstanding risk of radio frequency interference.”

Mulilo Renewable Project Developments (PTY) LTD hereby confirms it has no objection to the above requirement from SKA and to the above clause. Mulilo confirms that technology specific tests to the proposed projects have been undertaken by an agreed third party by SKA from which results of potential mitigation requirements have been established. Mulilo confirms that RFI Shielding best practices will be incorporated into the design and once the project has been constructed, detailed radio frequency measurements will be conducted to the satisfaction of the SKA project office to verify the mitigation of all risk of radio frequency interference on the SKA. Should it be shown that the risk has not been fully mitigated, further consultation and implementation of mitigation measures will be implemented to ensure compliance.
