APPLICANT: DE BEERS CONSOLIDATED MINES LTD.

- 1. It is confirmed that your Company's abovementioned application for the prospecting of diamonds and diamonds (general, alluvial and in kimberlite) in respect of the abovementioned property has been approved in terms of Item 6(3) of Schedule II of the Transitional Arrangements of the Mineral and Petroleum Resources Development Act, 2002 (Act 28 of 2002). - 2. Take note that the Regional Manager will execute the converted right on or before 30 October 2010.

- 4.1. Submit six (6) copies of documentary proof of your Company's full compliance with BEE, ensure that these documents are submitted to the Regional Office not later than 30 days prior to the date mentioned in paragraph 2 above.
- **4.2.** Make arrangements for the authorized representative(s) of your Company to be present and attend the signing of the converted mining right.
- A. Note further that in terms of Item 7(5) of the Transitional Arrangements of the Act, the signed/executed mining right must be subsequently lodged for registration at the Mineral and Petroleum Titles Registration Office, Pretoria, within 90 days after the said signing/execution.
- 5. Failure to comply may result in the withdrawal, suspension or cancellation of the right in question.
