The attached copies of correspondence between Messrs Milnex 189 BK and Transnet SOC Ltd (Transnet) refer please.

It is with great disappointment that Transnet has learned that a prospecting right has been granted to Messrs Coppersun Twelve (Pty) Limited for, on and over portions of the farm Fourteen Streams No 311 as currently owned by Transnet. The properties are currently utilized for the railway between Klerksdorp and Kimberley and forms part of one of the main rail corridor linking Kimberley with the ports of Cape Town and Port Elizabeth. In view of this, it is of national importance that these properties are reserved for this purpose.

The granting of mining right, reconnaissance permission, prospecting right and mining permits over properties utilized for railway lines in the various rail corridors are a serious concern for Transnet. Not only do these activities pose a serious risk for both the permit holder and Transnet, but also does Section 48 (1) of the Minerals And Petroleum Resources Development Act, 2002 stipulate that such permissions and / or rights not be issued in respect of railway lines.

The attitude as reflected in the copy of the letter from Messrs Milnex 189 BK dated 31 October 2011 is totally unacceptable to Transnet.

Under the aforementioned circumstances, your assistance is hereby requested in resolving the matter between Messrs Coppersun Twelve and Transnet. Should this not be forthcoming



- The CPA needs a copy of the draft Environmental Impact Assessment as well as an draft Environmental Scoping Report in order to make their inputs considering the environment and how this propose project will have an impact or not on their property.






