APPLICATION FOR MINING RIGHT: COPPERSUN TWELVE (PTY) LTD / FOURTEEN STREAMS

We refer to your letter dated 27 July 2011.

We do not at this stage answer to all aspects you refer to in your letter but do we reserve our right to do so at a later stage. Any aspect not answered or commented on can not be seen as an admission by Coppersun Twelve (Pty) Ltd.

The consultation process is an open process and do we hereby invite you to give your comments with regard to the application as the process proceeds.

1. AD PARAGRAPH 1

In this paragraph you object against the development of "any mining mineral application" on the property. There is no factual reasoning in the rest of your letter why you object and do you not give any reasons why you object.

2. AD PARAGRAPH 2

We do not see this as a valid comment and/or objection. It is clear that an appeal does not suspend any administrative decision.

3. AD PARAGRAPH 3

We do not agree. The property in question does not fall under those listed in Section 48(1) of the MPRDA. The advertisement you refer to is not an area defined as mentioned in Section 48(1)(d) of the Act. The notice we have does not specify that the Minister prohibit or restrict the granting of a Prospecting or Mining Right on the area in question. If your notice read differently, we kindly receive a copy thereof.

4. AD PARAGRAPH 4

The advertisement referred to was done in connection to the previous applications submitted.

5. AD PARAGRAPH 5

The Scoping Report was send to you on 29 July 2011. For your convenience we attach hereto a copy of the Scoping Report. We will provide you with a copy of the Environmental Impact Assessment once it has been submitted.

6. AD PARAGRAPHS 5.1 TO 5.3

We are not certain what these references are. Please clarify where after we will answer thereto.

7. AD PARAGRAPH 6

As indicated, we attach hereto a copy of the Scoping Report and will a copy of the EIA be forwarded to you once it has been submitted.

8. AD PARAGRAPH 7

This is noted. The documents requested are appended hereto.

9. AD PARAGRAPH RECOMMENDATION

We kindly refer you to the previous discussions and the agreement circulated between the parties. It is still our clients' instruction that at least a verbal agreement has been concluded between the parties on the terms and conditions of the agreement. For your convenience we again attach a copy of the surface usage agreement hereto. This agreement addresses all your concerns that were raised and will the landowner benefit from implementation thereof.

10. AD PARAGRAPH SHOULD MINING BE ALLOWED

From the Mining Work Program it is clear that only a limited amount of hectares will be mined on the property. Your client will be fully compensated for the loss of usage on these areas as indicated in the agreement referred to in paragraph 9 above. The property will be rehabilitated as mentioned in the agreement attached hereto and as mentioned in the Environmental Management Programme. It is thus not necessary to provide your client with other virgin land of plus minus the same hectares. If the property is stocked with cattle, goats and/or other animals in accordance with the guidelines of the Department of Agriculture (i.e. 9 hectares per large stock unit and 1.5 hectares per small stock unit) and it

later seems that there is not enough grazing available on the farm for the animals due to the mining activities, our client will always be open for discussions in this regard. This will be subject to your client complying with the animal capacity principals prescribed by the Department of Agriculture.

We have already proposed the payment of 11% royalties from the mining operations.

We addressed consultation letters to all the parties listed in the last paragraph of your letter.



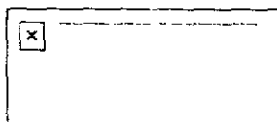


