RE: APPLICATION FOR ENVIRONMENTAL AUTHORISATION AND REGISTRATION OF WATER USES ON THE REMAINING EXTENT OF THE FARM NGODWANA 1030 JT, MPUMALANGA, CITY OF MBOMBELA LOCAL MUNICIPALITY.

Background:

The application for Environmental Authorisation as well as registration of section 21(c) & (i) water uses under General Authorisation for remediation activities of the Sappi Ngodwana Dam, on the remaining extent of the Farm Ngodwana 1030 JT under the jurisdiction of the City of Mbombela Local Municipality submitted by your company has been assessed by the Mpumalanga Department of Agriculture, Land Reform and Rural Development (DALRRD) Provincial Shared Service Centre (PSSC) based on the mandate and functions performed by DALRRD.

- 1.1. Status of the land ownership and adjacent properties, existing land uses and the proposed activities.
- 1.2. The exiting departmental projects, programmes and initiatives on the application site and on adjacent properties.
- 1.3. The impact of the proposed application towards Land reform and Rural development.

2. Assessment outcomes:

- Land ownership of the application site is not conflicted to DALRRD's programme and projects and the attached title deed is explicit in terms of the current ownership.
- 2.2. In terms of the District Rural Development Plan (2019) DRDP the application property is located in the vicinity of functional region-2, and the proposed activity has no negative impact on the DRDP.
- 2.3. The proposed activity is acknowledged as for the registration of water rights on the application property and does not have negative impact on the mandate of DALRRD in relation to the property and the proposed activity.
