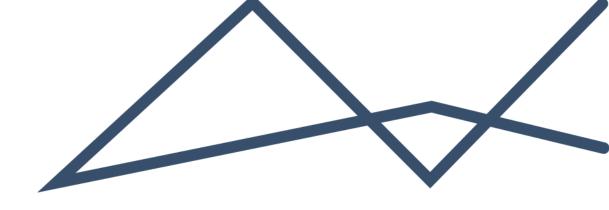

1 INTRODUCTION

Chemwes (Pty) Ltd also known as Mine Waste Solutions (hereafter referred to as the applicant) has appointed Environmental Impact Management Services (Pty) Ltd (EIMS) as the Environmental Assessment Practitioner (EAP) to assist with undertaking the required authorisation processes (including the statutory public participation), and to compile and submit the required documentation in support of application for:

- Environmental Authorisation (EA) in accordance with the NEMA- Listed activities:
 - Listing Notice 1: Activities 27 and 10.
 - Listing Notice 3: Activities 12 and 14.
- Water Use Licence (WUL) in accordance with the National Water Act NWA (Act 36 of 1998) Listed activity/ies:
 - Section 21 (c) and (i).

The applicant wishes to expand their reclamation activities to the Mispah 1 TSF through the construction of a reclamation pump station and installation of additional piping infrastructure to meet the planned Life of Mine (LoM) plan. The planned infrastructure will include a new process water and slurry pipeline and reclamation pump station. The infrastructure planned is a new 600mm slurry- and 500mm low-pressure process water pipelines of almost 9km from the East Pump Station to the Mispah 1 TSF Reclamation Pump Station. Both the slurry and process water pipeline to cross the Vaal River at Noligwa Bridge.

The proposed project is located on Mispah 274 (RE), Zuiping 394 (1), Chrystalkop 69(RE), Hoekplats 598 (RE), Modderfontein 440(4), Viljoenskroon RD 598 (RE), across the City of Matlosana Local Municipality and Moqhaka Local Municipality, North West and Free State provinces, respectively.

2 OBJECTIVES OF THE PUBLIC PARTICIPATION

South Africa, being one of the countries with the most progressive constitutions, enshrined the public's right to be involved in decisions that may affect them in its Constitution. Section 57(1) of the new Constitution that provides: "The National Assembly may (b) make rules and orders concerning its business, with due regard to representative and participatory democracy, accountability, transparency and public involvement". This provision, along with several others gave rise to many new trends in South African legislation. In environmental legislation, the idea of public participation (or stakeholder engagement) features strongly and especially the National Environmental Management Act (Act 107 of 1998, NEMA) and the recent regulations passed under the auspices of this Act makes very strict provisions for public participation in environmental decision-making.

Public participation can be defined as..." a process leading to a joint effort by stakeholders, technical specialists, the authorities and the proponent who work together to produce better decisions than if they had acted independently". From this definition, it can be seen that the input of the public is regarded as very important indeed.

The PPP is designed to provide sufficient and accessible information to Interested and Affected Parties (I&APs) in an objective manner to assist them to:

• During the Basic Assessment Process:

- Verify that their issues have been recorded;
- o Comment on the findings of the environmental assessments; and

Provide relevant local information and knowledge to the environmental assessment.

The PPP is a requirement of several pieces of South African Legislation and aims to ensure that all relevant I&APs are consulted, involved and their opinions are taken into account and a record included in the reports submitted to Authorities. The process ensures that all stakeholders are provided this opportunity as part of a transparent process which allows for a robust and comprehensive environmental study. The PPP for the necessary authorisation required for the Harmony Mispah Pipelines project needs to be managed sensitively and according to best practises in order to ensure and promote:

- Compliance with international best practice options;
- Compliance with national legislation;
- Establishment and management of relationships with key stakeholder groups; and
- Encouragement of involvement and participation in the environmental study and authorisation/approval process.

As such, the purpose of the PPP and stakeholder engagement process is to:

- Introduce the proposed project and process for the authorisation project;
- Explain the environmental authorisation;
- Determine and record issues, concerns, suggestions, and objections to the project;
- Provide opportunity for input and gathering of local knowledge;
- Establish and formalise lines of communication between the I&APs and the project team;
- Identify all significant issues for the project; and
- Identify possible mitigation measures or environmental management plans to minimise and/or prevent negative environmental impacts and maximise and/or promote positive environmental impacts associated with the project.

This Public Participation Report (PPR) lists all verbal and written issues raised by I&APs during the call to register period from 23 November 2022 to date. A breakdown of the PPP is given within the remaining sections of this PPR.

2.1 LEGAL COMPLIANCE

The PPP must comply with all environmental legislation that requires public participation as part of an application for authorisation or approval; namely, the National Environmental Management Act (NEMA, Act No. 107 of 1998).

Adherence to the requirements of the above-mentioned Act will allow for an Integrated PPP to be conducted, and in so doing, satisfy the requirements for public participation referenced in the Act. The details of the Integrated PPP are provided below.

3 IDENTIFICATION OF INTERESTED AND AFFECTED PARTIES (I&APS)

An initial I&AP database has been compiled from historic projects in the area and Windeed searches to obtain the contact details of the surrounding landowners. The I&APs referred to in the PPR include:

4 NOTIFICATION OF INTERESTED AND AFFECTED PARTIES

This section provides details on the notifications that were distributed as part of the consultation process to date.

4.1 INITIAL NOTIFICATION OF KEY I&APS

The PPP commenced on the 23rd November 2022 with an initial call to register notification. Notification during this initial consultation was given in the manner described below.

4.1.1 REGISTERED MAIL, FAXES AND EMAILS

Notification letters in English and Setswana were distributed to pre-identified I&APS through either registered mail, faxes, and/or emails.

The notification documents included the following information:

- List of anticipated activities to be authorised;
- Sufficient detail of the proposed development to enable I&APs to assess/surmise what impact the development will have on them or on the use of their land;
- The purpose of the proposed project;
- Details of the application processes associated with proposed activities;
- Details of the affected properties (including a locality map);

- Contact details of the EAP.

5 NOTIFYING INTERESTED AND AFFECTED PARTIES OF THE DECISION

Interested and Affected Parties will be notified via either fax, registered mail, sms and/or email, where contact details are available of the decision once available including the appeal process should they wish to appeal the decision.

6 RECORD OF ISSUES RAISED

Comments on the proposed Harmony Mispah pipelines project were solicited from pre-identified and registered I&APs and key stakeholders. To date the following comments have been received:

- Request of a locality map and kml files of the proposed pipelines by SANRAL.
- DFFE Biodiversity Conservation Directorate stated that they had no objections to the project provided that recommendations of the Terrestrial Specialist are followed.
- DFFE Biodiversity Conservation Directorate stated that the project area falls within the Mispah Game Reserve and the Protected Area Directorate must be engaged in that regard.
- Enquiry on if and how the proposed project will be affecting Transnet railway lines.
- Applicant provided motivation for the delisting of the aforementioned protected area known as "Mispah Game Reserve" (Motivation letter attached)
- Correspondence with Department of Economic and Small Business Development, Tourism and Environmental Affairs (DESTEA) regarding the delisting of the protected area.

7 CONCLUSIONS AND RECOMENDATIONS

The comments received during the initial call to register period and BAR Availability for Public Review period were used to inform the compilation of this PPR and the Final BAR.
