for residents on the outskirts of Ermelo. This came after he established the Shalom

Marathon Club in Ermelo in 2011

He is looking forward to competing in his 16th marathon and what makes it even more special is that he will be running it with his good friend, Mbongiseni Ndlangamandla, who he regards a brother.

"Although we do not have the same parents our surnames connects us as brothers," Petros said.

They recently tokk part in the annual Pongola Sugar Cane race and were there to grab the last chance to qualify for the iconic Comrades Marathon, that will take place on Sunday, 9 June.

The marathon will begin at 5.30am from Durban to Pietermaritzburg, with the cut off time being 5.30pm.

Petros completed the Pongola Sugar Cane race in 3:18,23 (batch B) and claimed the first prize in the masters category (50 years+).

Mbongiseni surprised everyone including himself when he finished in 3:58,43 (batch D) at his first attempt to qualify.

'We are both relieved and happy that we have qualified, but I am even more happy for Mbongiseni, because it was his last chance after missing all other qualifiers due to

His best time in the Comrades is in 2006 when he completed the race in six hours and 42 minutes, this was also the year that he learned one of the hardest lessons in running.

He told he *Highvelder* that his mentor always said, "no new things on race day," but at this Comrades event he saw a nice pair of socks at one of the stalls and decided to buy it for the race.

"As I was approaching the 25km mark I felt my shoes hurting my ankles and I knew I was in trouble.

I had to stop at the halfway mark, so that the medical personnel could fix me up to complete the race.'

He added that if it was not for the bad choice he had made of using the new socks, he was sure that he would have had a better finishing time.

Petros recently encouraged a young drug addict to join him and soon this youngster's life was turned around.

"I realised that through running I can make a difference in people's lives, and it was fulfilling to see the change in this youngster's life."

Petros is also the principal at Siyazi Primary School in Breyten, where he lives to inspire young children to live a healthy lifestyle and to exercise.

Although he always wanted to become a doctor, he now knows that teaching is his calling. This inspiring man is also a pastor. and felt that for him to make God a part of his marathon clubs he will be naming them accordingly. "Shalom means God of peace. The Conquerors Club is taken from the verse in Philippians 4:13, which states: "I can do all this through Him who gives me strength," he concluded.
