SUBMISSION OF FINAL SCOPING REPORT

Phezukomoya Wind Power (Pty) Ltd are applying for environmental authorisation to construct the Phezukomoya 315 MW Wind Energy Facility (WEF). Arcus Consultancy Services (Pty) Ltd has been appointed by Phezukomoya (Pty) Ltd to conduct the Environmental Impact Assessment (EIA) process as required by the National Environmental Management Act, 1998 (Act No. 107 of 1998) (NEMA), as amended. The proposed development site is located approximately 8 (eight) kilometres south east of the town of Noupoort in the Northern Cape Province, bordering the Eastern Cape Province. The proposed development site falls within the Umsobomvu Local Municipality, in the Pixley ka Seme District Municipality in the Northern Cape, as well as in the Inxuba Yethemba Local Municipality and Chris Hani District Municipality in the Eastern Cape. The towns of Middelburg and Colesburg are located approximately 28 km and 59 km to the south and north east of the site respectively.

The Environmental Impact Assessment (EIA) process that is being followed has now reached the end of the Scoping Phase. The Draft Scoping Report was made available to I&APs for the statutory 30 day period in June 2017 for comment. The Final Scoping Report has taken into consideration comments received during the commenting period and has been submitted to the Department of Environmental Affairs (DEA).

The Final Scoping Report is available on the Company Website www.arcusconsulting.co.za

Following submission of the Final Scoping Report, the DEA will either accept or reject the report. If the Final Scoping Report is accepted by the DEA, then the EIA Phase of the project will commence. All registered I&APs will receive further opportunity to participate in the EIA Phase, where a Draft and Final Environmental Impact Assessment Report will be made available for further comment. This is anticipated to take place in October 2017.
