NOTIFICATION OF AVAILABILITY OF DRAFT ENVIRONMENTAL IMPACT ASSESSMENT REPORT FOR THE PROPOSED PHEZUKOMOYA WIND ENERGY FACILITY AND ASSOCIATED GRID CONNECTION, NORTHERN AND EASTERN CAPE PROVINCES

Phezukomoya Wind Power (Pty) Ltd are applying for environmental authorisation to construct the Phezukomoya 315 MW Wind Energy Facility (WEF). Arcus Consultancy Services (Pty) Ltd has been appointed by Phezukomoya (Pty) Ltd to conduct the Environmental Impact Assessment (EIA) process as required by the National Environmental Management Act, 1998 (Act No. 107 of 1998) (NEMA), as amended. The proposed development site is located approximately 8 (eight) kilometres south east of the town of Noupoort in the Northern Cape Province, bordering the Eastern Cape Province. The proposed development site falls within the Umsobomvu Local Municipality, in the Pixley ka Seme District Municipality in the Northern Cape, as well as in the Inxuba Yethemba Local Municipality and Chris Hani District Municipality in the Eastern Cape.
