SANRAL do not wish to be registered as a I & AP.

The mining area is large and contribute significantly to the reducing of the service life of surface roads traversed by coal transport vehicles between Elandsfontein and presumably Wilge and Kusile Power Stations.

The extent of heavy vehicle movements/volumes from Elandsfontein Colliery using the N12 or N4 or parts therefore is not clear.

Although SANRAL has no objection to the issuing of the necessary WULA and EIA approval, the issuing thereof should be made subject to the preparation of a comprehensive traffic study by a registered traffic engineer and the forwarding thereof to SANRAL and the Mpumalanga Department of Roads and Transport for comments and approval.

This traffic impact study must include all heavy vehicle traffic between Elandsfontein Colliery and E80's over surfaces roads traversed, Elandsfontein Colliery contribution to negate past and future road degradation and monetary contribution towards maintenance of provincial roads affected.

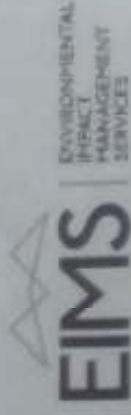
