NOTICE OF A BASIC ASSESSMENT PROCESS FOR THE PROPOSED DECOMMISSIONING (CLOSURE) OF THE SHAKAVILLE LANDFILL, KWADUKUZA LOCAL MUNICIPALITY, KWAZULU NATAL PROVINCE

Notice is hereby given in terms of Chapter 5 of the National Environmental Management Act (NEMA), 1998 (Act No. 107 of 1998) and Waste Management Activities listed in terms of the National Environmental Management: Waste Act, 2008 (NEM:WA) (Act No. 59 of 2008) as amended, that the Department of Environmental Affairs (DEA) is assisting the KwaDukuza Local Municipality to apply for a Decommissioning Licence for the disused the Shakaville landfill. DEA has therefore appointed GA Environment (Pty) Ltd as independent Environmental Consultants, to undertake the Basic Assessment and Waste Management Licence Application for the landfill.

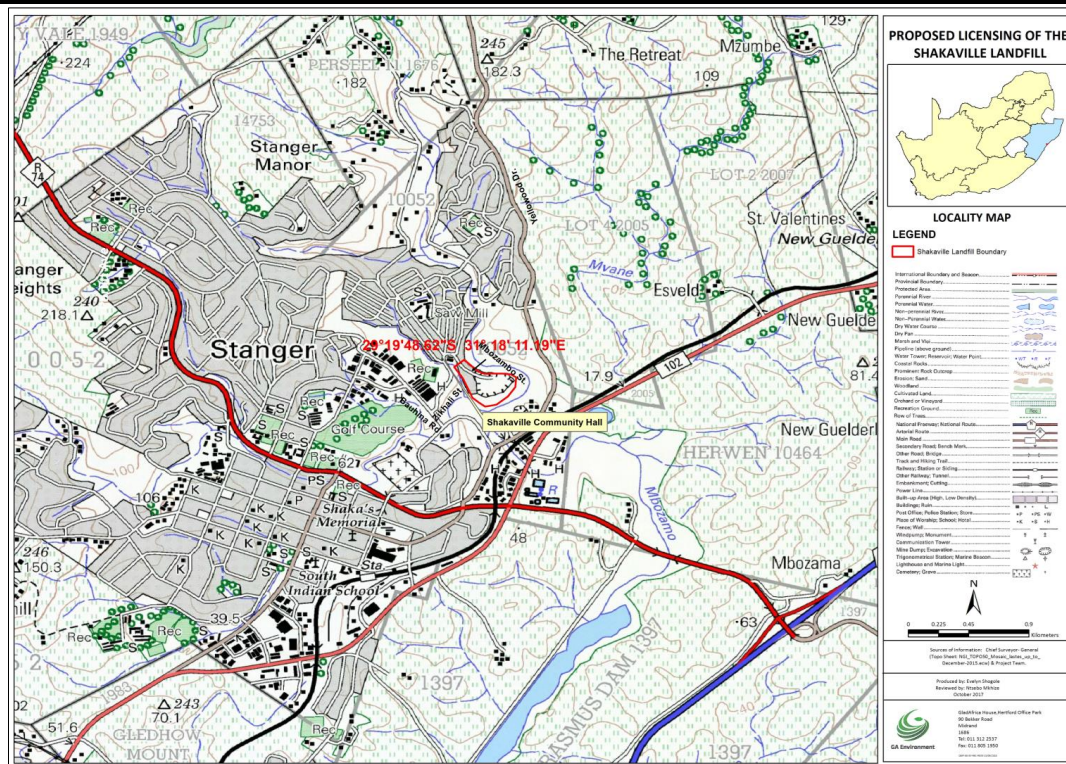


Figure 1: Locality map of the Shakaville Landfill/ Isithombe 1: Indawo yokulahlwa imfucuzwa yaseShakaville

The Shakaville landfill occupies an area of approximately 80 000m² (8 Ha) and is located on Erf 3595 Stanger within the KwaDukuza Local Municipality. Direct access is available from Mbozambo Street in Shakaville. The site centre co-ordinates are 29°19'48.62"S; 31° 18' 11.19"E. The edges of the site are within the riparian area of as tributary of the Mbozamo River. The tributary surrounds the landfill in almost all directions with the exception of the north westerly direction where access to the site is available. Refer to Figure 1 for the Locality Map of the site.

The Shakaville landfill ceased operations in the year 2000 after approximately 30 years of receiving general waste from areas located within the KwaDukuza Local Municipality boundaries. The Local Municipality currently disposes of waste at the Dolphin Coast Landfill Management (DCLM), however pockets of illegal dumping of waste is evident on the site boundaries. The Shakaville landfill was noted to have naturally rehabilitated as vegetation was noted to have been fully established. Current land use on site include pockets of informal housing infrastructure and the occupants are regarded as historical reclaimers of waste that have since occupied the land when the disposal of waste ceased. Approximately 20 families currently occupy the landfill site area. Infrastructure noted on site include a gate, sewer manholes and groundwater monitoring boreholes. Records of waste streams that have historically been disposed of on the site are unavailable. Approximately 20 families currently occupy the landfill site area. The infrastructure on site is limited to the informal residential structures, a gate and a fence of no more than 20m located close to the gate, sewer manholes, groundwater monitoring boreholes, a tap and illegal electricity connections.

According to the NEM: WA, 2008 (Act No. 59 of 2008) as amended, the decommissioning of a landfill requires a Waste Management License as per **Category A (Activity No. 14)** of Government Notice 921 of 2013, and an Environmental Impact Assessment process, as stipulated in the NEMA EIA Regulations (2014) as amended, made under section 24(5) and 44 of the NEMA, 1998 (Act No. 107 of 1998) as amended. As the Shakaville landfill is located within the KwaZulu Natal Province, the Waste Management Licence for the Shakaville landfill will be issued by the KwaZulu Natal Department of Economic Development, Tourism and Environmental Affairs (EDTEA).

Lesi saziso sikhishwa ngokuvumalana neSigaba 5 soMthetho Kazwelonke Wokunakekelwa Kwemvelo (NEMA), ka-1998 (u-Act No. 107 ka-1998) kanye neMisebenzi Yokuphathwa Kwemfucuzwa ebhaliswe ohlwinu ngokuvumelana nenqubo Yokuphathwa Kwezemvelo Kuzwelonke: uMthetho Wokulahlwa Kwemfucuzwa, ka-2008 (NEM:WA) (u-Act No. 59 ka-2008) owachibiyelwa, uMnyango Wezokunakekelwa Kwezemvelo (DEA) osiza uMasipala Wendawo YaseKwaDukuza ukuba uwusebenzise ngenjongo yokukhishwa Kwemvume Yokuvalwa kwendawo yokulahlwa udoti yaseShakaville. I-DEA manje iqoke inkampani ezimele iGA Environment (Pty) Ltd ukuba ibe Abeluleki Bemvelo abangachemile, ukuze yenze Ukuhlola Okuyisisekelo nokuba kutholakale Imvume Yokuphathwa Kwemfucuzwa ngokuqondene nale ndawo.

Lesi siza saseShakaville sithatha indawo engaba amamitha sikwele angu-80 000m² (8 Ha) futhi isendaweni yaseStanger ewu-Erf 3595 ngaphansi kukaMasipala Wendawo yaKwaDukuza. Indlela eya khona ingena kuMbozambo Street eShakaville. Inombolo yeGPS noma ama-co-ordinates ale ndawo uma uphakathi nayo angu-29°19'48.62"S; 31° 18' 11.19"E. Imingcele yalesi siza iwugu lwemifudlana engenela eMfuleni iMbozamo. Le mifula eyimingenela izungeze le ndawo cishe kuzo zonke izinhlangothi ngaphandle kwasohlangothini olusenyakatho ntshonalanga lapho kungenwa ngakhona uma uza kulesi siza. Bheka **Isithombe 1** ukuze ubone ibalazwe lendawo yesiza.

Le ndawo ebicwaliswa yaseShakaville iyeke ukusebenza eminyakeni yawo-2000 ngemva kweminyaka ecishe ibe ngu- 30 ithola imfucuzwa evamile evela ezindaweni ezingaphansi kukaMasipala Wendawo waKwaDukuza. Okwamanje uMasipala wendawo ulahla udoti endaweni yokulahlwa udoti iDolphin Coast Landfill Management (DCLM). Le ndawo yokulahlwa udoti isivuselele ngokwemvelo futhi ingxube yezimila zokufika nezendabuko ziyazimilela kule ndawo. Amarekhodi ohlobo lodoti oye walahlwa emlandweni wale ndawo awatholakali. Ukuphinde kutholakale udoti esikhathini esidlule bekwenziwa kule ndawo yokulahlwa udoti, abanye balabo ababesuke bewufuna namanye amaqembu baye bahlala kule ndawo bakha imijondolo. Okwamanje kunemindeni engaba ama-20 ehlala kule ndawo okwakulahlwa kuyo udoti. Izingqalazizinda zivumelana nendawo yasemijondolo kuphela, isango ncingo lokubiyela olungedluli kumamitha angu-20, izindlu zangaseze ezigujiwe, amanzi adonswa phansi, ompompi kanye ngesi odonswa ngokungemthetho.
