NOTICE OF A BASIC ASSESSMENT PROCESS FOR THE PROPOSED DECOMMISSIONING (CLOSURE) OF THE EMADLANGENI LANDFILL, EMADLANGENI LOCAL MUNICIPALITY, KWAZULU NATAL PROVINCE

Notice is hereby given in terms of Chapter 5 of the National Environmental Management Act (NEMA), 1998 (Act No. 107 of 1998) and Waste Management Activities listed in terms of the National Environmental Management: Waste Act, 2008 (NEM:WA) (Act No. 59 of 2008) as amended, that the Department of Environmental Affairs (DEA) is assisting the Emadlangeni Local Municipality to apply for a decommissioning licence for the eMadlangeni landfill. DEA has therefore appointed GA Environment (Pty) Ltd as independent Environmental Consultants, to undertake the Basic Assessment and Waste Management Licence Application for the landfill.




Figure 1: Location of the eMadlangeni Landfill/ Isithombe 2: Indawo yokulahla imfucuza yaseMadlangeni

The eMadlangeni landfill occupies an area of approximately 62000m² (\pm 6 Ha) and is located on Erf 10000 and Erf 1006 eMadlangeni within boundaries of the eMadlangeni Local Municipality. The landfill is approximately 4km north of the R34 which provides access into the Utrecht CBD. Direct access to the site can be gained from the surfaced President Street leading to Paullpietersburg. The site centre co-ordinates are 27°39'18.65"S; 30° 20' 28.20"E. Refer to **Figure 1** for the Locality Map of the site.

The eMadlangeni landfill receives general waste from areas located within the eMadlangeni Local Municipality. It is unknown when the eMadlangeni landfill commenced with the disposal of waste on the site although aerial images from as early as 2006 do however indicate that disposal was already taking place on site at that time. Records of waste streams that have historically been disposed off on the site are unavailable. Reclaiming of waste occurs on site and contributes to the local economy.

Environmental problems noted on this site include visual nuisances such as windblown litter, air quality problems from the burning of waste, soil erosion etc. With the exception of the fence, a gate, manholes, a tap, a toilet, a shipping container, a prefabricated building and a brick building, no other infrastructure is available on site.

According to the NEM: WA, 2008 (Act No. 59 of 2008) as amended, the decommissioning of a landfill requires a Waste Management License as per **Category A (Activity No.14)** of Government Notice 921 of 2013, and an Environmental Impact Assessment process, as stipulated in the NEMA EIA Regulations (2014) as amended, made under section 24(5) and 44 of the NEMA, 1998 (Act No. 107 of 1998) as amended. As the eMadlangeni landfill is located within the KwaZulu Natal Province, the Waste Management Licence eMadlangeni will be issued by the KwaZulu Natal Department of Economic Development, Tourism and Environmental Affairs (EDTEA).

Lesi saziso sikhishwa ngokuvumelana neSigaba 5 soMthetho Kazweloneke Wokunakekelwa Kwemvelo (NEMA), ka-1998 (u-Act No. 107 ka-1998) kanye neMisebenzi Yokupathwa Kwemfucuza ebhaliswe ohlwini ngokuvumelana nenqubo Yokupathwa Kwezemvelo Kuzwelone: uMthetho Wokulahlwa Kwemfucuza, ka-2008 (NEM:WA) (u-Act No. 59 ka-2008) owachibiyelwa, uMnyango Wezokunakekelwa Kwezemvelo (DEA) osiza uMasipala Wendawo YaseMadlangeni ukuba uwusebenzise ngenjongo yokukhishwa Kwemvume Yokuvalwa kwendawo yokulahla udoti ekhona manje yaseMadlangeni. I-DEA manje iqoke inkampani ezimeli iGA Environment (Pty) Ltd ukuba ibe Abeluleki Bemvelo abangachemile, ukuze yenze Ukuhlola Okuyisisekelo nokuba kutholakale Imvume Yokupathwa Kwemfucuza ngokuqondene nale ndawo.

Indawo yokulahla udoti yaseMadlangeni ithatha indawo engaba amamitha sikwele angu-62000m² (\pm 6 Ha) futhi isendaweni yaseMadlangeni engu- Erf 10000 no- Erf 1006 ngaphansi kukaMasipala Wendawo waseMadlangeni. Le ndawo isebangeni elingaba ngu-4km enyakatho ka-R34 ongenela edolobheni lase-Utrecht. Uma ufuna ukuya kule ndawo ngokuqondile ungangena ngokuqhamuka ngomgwaqo u-President Street oya e-Paullpietersburg. Ama-coordinates eGPS enkaba yale ndawo athi 27°39'18.65"S; 30° 20' 28.20"E. Bheka **isithombe 1** esiphethe iBalazwe Lendawo ukuze uyibone.

Le ndawo yaseMadlangeni yamukela udoti ovela ezindaweni ezhilukahlukene ngaphansi kukaMasipala Wendawo yaseMadlangeni. Akwaziwa ukuthi kwaqalwa nini ukulahlwa kodoti kule ndawo nakuba izithombe zibonisa ukuthi ngisho nango-2006 wase ulahlwa udoti ngaleso sikhathi. Awatholakali amarekhodi udoti obulokhu ulahlwa kule ndawo. Ukulandwa komunye udoti ngenjongo yokuwusebenzisa bekulokhu kweneka futhi kwenezela emnothweni wendawo.

Izinkinga ezithintsa ezemvelo kule ndawo zihlanganisa ukungcola okuhleli obala okulethwa umoya, ukungcola komoya ngenxa yokushiswa kwemfucuza, ukuguguleka komhlabathi nokunye. Nakuba le ndawo ibiyelwe futhi inesango, imigodi embiwe, impompi, indlu yangasese, indlu yensimbi yokuthutha, izakhiwo zesikhashana nezakhiwo zezitini azikho ezinye izingqalasizinda ezikhona kule ndawo.
