DEFF through the sub-directorate Forestry Regulations and Support is the authority mandated to implement the National Forests Acts No. 84 of 1998 by regulating the use of natural forests and protected trees species in terms of the said Act. With reference to the above-mentioned document received on the date 07/09/2020, the proposed project falls within the five vegetation units namely the Dry Coast Hinterland Grassland, Moist Coast Hinterland Grassland, KwaZulu-Natal Sandstone Sourveld, KwaZulu-Natal Hinterland Thornveld and the Eastern Valley bushveld. Vegetation within these units consists predominately of open thornved species such as Acacia species, Cussonia spcicata, Ehretia rigida and Grewia occidentalis species. In addition, most of the vegetation noted along the proposed pipeline route is highly disturbed and consists of scattered indigenous tree species and alien invasive plant species due to the project footprint been previously affected by the construction of the bulk water pipeline and anthropogenic activities within the area. Furthermore, as per telephonic conservation with the Environmental Consultant, the proposed reticulation will not have not any impact on natural forests or protected tree species as per section 7 and/or 15 of the National Forest Act no. 84 of 1998 as amended.
