NOTICE OF DRAFT BASIC ASSESSMENT REPORT REVIEW

PROPOSED WATER PIPELINE TO THE BHOBHOYI WATER TREATMENT WORKS, NEAR PORT SHEPSTONE, KWAZULU-NATAL

Notice is hereby given in terms of the following:

- The Environmental Impact Assessment (EIA) Regulations of 2014 (as amended), in terms of the National Environmental Management Act (Act No. 107 of 1998) (NEMA); and
- The National Water Act (Act No. 36 of 1998) (NWA).

PROJECT OVERVIEW:

Water for the Umzimkhulu Regional Water Supply Scheme is currently sourced from the licenced river flows in the uMzimkhulu River from where it is then treated and distributed to all users in the system. Raw water abstraction takes place at the St Helen's Rock abstraction point where water is pumped to an off-channel storage dam that feeds Bhobhoyi Water Treatment Works (WTW).

The Ugu District Municipality (the Applicant) has proposed the development of a new pipeline of approximately 3.4 km from the St. Helen's Rock abstraction works to the Bhobhoyi WTW (the Project). The proposed pipeline is located within Wards 12, 14, 23 and 34 of the Ray Nkonyeni Local Municipality (RNLM), KwaZulu-Natal.

There is currently only one functioning ND700/600 pipeline delivering water to the storage dam and Bhobhoyi WTW, which has limited capacity on its own and which requires complete system shutdown for ongoing maintenance. Bifurcation pipework to and from the storage dam is prone to leaks and thus ongoing maintenance shutdowns and risk of serious failure.

To achieve the licenced 88 Ml/d on average, the whole system requires the capacity to deliver up to 108 Ml/d (peak) at times in order to maintain this average. The existing ND700/600 pipeline from the St. Helen's Rock abstraction works to the existing Bhobhoyi WTW on its own cannot do this. The existing ND700/600 and proposed ND700 will therefore need to accommodate a combined flow of 1.25m³/s at a maximum mean velocity of 1.87 m/s.

The proposed new abstraction weir (separate Application for Environmental Authorisation) and delivery pipeline to the WTW will resolve all the above issues and will have the strength and assured capacity to deliver 88 Ml/d average (108 Ml/d peak) to the 900 MI storage dam and to the WTW, as per the abstraction licence. The proposed WTW upgrade will then match this 88 M/d (108 Ml/d peak).

BACELA ushwele kwa-Eskom abahlali baKwaDunjazana, eBhobhoyi ngaseSayidi ngokuxhuma ugesi ngokungemthetho nasekholele ekutheni kushe izigubhu zikagesi wabo. Ukusha kwalezigubhu 'transformers' ezimbili abaxhume kuzo ugesi bathi sekudale ukuthi bahlale ebunyaneni nokuyisimo esibeka impilo yabo engozini yabayizigebengu. NgoLwesine olwedlule bahlangane noMnuz Sbu Khambule noMnuz Thulani Dlamini bakwa-Eskom ehholo lomphakathi e-ABC lapho bevume khona abahlali ukuthi abanye babo bonile ngokuzixhumela ugesi kodwa abanye babo banogesi osemthethweni nabawukhokhelayo noma abawuthenga kwa-Eskom. Abahlali bathe bacela ushwele kwa-Eskom ngoba impilo inzima ngaphandle kwagesi kanti izoni ziyawucela ushwele noma ngabe sezizagwethwa enkantolo, kungakho nabo becele ushwele kwa-Eskom nokusho ukuthi kumele bashaywe ngoswazi oluncane bese befakelwa izigubhu zabo zikagesi ezinamandla. Abahlali bacele ushwele nje uMnuz Khambule ubeme ngemigomo yakwa-Eskom ethi uma ubanjwe u-Eskom okokuqala ukuthi uzixhumele ugesi kumele ukhokhe uR6 000, uma uphinde wabanjwa ukhokha R12 000, uma ubanjwe okwesithathu u-Eskom ukhipha izintambo zakhe, isigubhu sakhe nesigxobo sakhe esiletha ugesi kwakho bese uyaboshwa. UMnuz Khambule uthe u-Eskom udinga ukuthi umuzi ngamunye onogesi wezinokanyoka ukhokhe uR3 000

bese lena enye imali uyikhokha kancane kancane, bese kungena ithimba labo liyabheka ukuthi ayikho yini eminye imizi engawukhokheli ugesi kuleyo ndawo, bese kubhekwa nokuthi bakhokhe bonke yini abebenogesi ngokungemthetho ngaphambi kokuthi bangene nohlelo lokufaka izigubhu ezintsha. UMnuz Khambule uthe ugesi ufakwa u-Eskom noma umasipala wendawo. "KwaMasinenge nje kunemizi eseceleni laphaya eyafakelwa ugesi umasipala. Imali lena ekhokhwayo igunyazwe abalawula ugesi namanani awo kuzwelonke uNational Energy Regulator of SA (NERSA). Umasipala ungabafakela abantu ugesi uma bewucele ngesikhathi sezimbizo se-IDP," kusho uKhambule. IKhansela lasewadi 23 uMnuz Mfanufikile Mngqosini uthe umasipala ugxile ekufakeleni ugesi imizi emisha. "Asingayihlanganisi nale yemizi ka-Eskom. Leya ndawo beseyifakelwe ugesi u-Eskom. Yebo umasipala uyawufaka ugesi ngokusebenzisana no-Eskom noma ngayedwana ngokusebenzisa imali yamagranti," kusho uMngqosini. Omunye umholi womphakathi uMnuz Senzo Madiba, uthe bacela ushwele kwa-Eskom. "Imali ewu R3 000 inkulu kakhulu abantu abasebenzi, baphila ngezibonelelo zikahulumeni, kunabadala abahola impesheni. Umphakathi ucela ukukhokha iR1 000. Sicela ushwele, uma wonile nenkantolo iyakunika ushwele uma ulivuma icala futhi," kusho uMadiba. UMnuz Khambule uthe bayazithatha zinjalo izicelo zomphathi bayozethulela abaphathi babo emhlanganweni wabo. "Sizoxhumana nabo abaholi bomphakathi ukuze sibuyise impendulo," kusho uKhambule.
