NOTIFICATION REGARDING AN APPLICATION FOR A PROSPECTING RIGHT ON A PORTION OF PORTION 1 OF THE FARM MODDERFONTEIN 76 IR IN THE GAUTENG PROVINCE

On behalf of our client **Atoll Metal Recovery (Pty) Ltd**:

Environmental Impact Management Services (Pty) Ltd (EIMS) has been appointed by Atoll Metal Recovery (Pty) Ltd (Atoll) (the applicant) to assist in preparing and submitting a Basic Assessment Report (BAR) and undertaking a Landowner and Public Consultation Process, in support of a Prospecting Right Application.

Notice is given of an application for a Prospecting Right in terms of Section 16 of the Mineral and Petroleum Resources Development Act, 2002 (Act 28 of 2002) (MPRDA) and an Application for Environmental Authorization in terms of Chapter 6 of GNR 982 promulgated under the National Environmental Management Act (Act 107 of 1998) (NEMA) to prospect for aggregate and dolomite over a portion of portion 1 of the farm Modderfontein 76IR which is located approximately 5 km east of Benoni and 5 km north of Brakpan, in Gauteng, South Africa.

A previous Prospecting Right Application was submitted by the Applicant under reference number GP30/5/1/1/2/10382PR. Following the results of the public consultation for that application, the size of the proposed prospecting area has been reduced and an amended application has now been submitted under reference number GP 30/5/1/1/3/2/1 (10415) EM.

This correspondence serves as initial notification of the amended Prospecting Right Application and relevant processes in accordance with the requirements of Section 16 of the Minerals and Petroleum Resources Development Act (Act 28 of 2002) (MPRDA) and Section 24 of the National Environmental Management Act (Act 107 of 1998) (NEMA). The application will be undertaken in accordance with the requirements of the MPRDA, NEMA and the associated regulations and has been lodged at the Department of Mineral Resources – Gauteng.

A brief summary of the project is provided below. For more information, including a map of the application area, please refer to the attached Background Information Document (BID).

The applicant has applied for a Prospecting Right that will enable them to ascertain if economically viable deposits of aggregate (Quartzite, conglomerate, diamictite, sandstone) and dolomite exist within areas applied for. The area has been disturbed by previous mining activities. No invasive prospecting activities will be required, only desktop evaluation of existing data. As such no significant environmental impacts are expected should the proposed prospecting be undertaken.

Project Introduction:

Environmental Impact Management Services (Pty) Ltd (EIMS) has been appointed by Atoll Metal Recovery (Pty) Ltd (the applicant) to assist in preparing and submitting a Basic Assessment Report (BAR) and undertaking a Public Participation Process, in support of a Prospecting Right Application.

Aim of the Background Information Document (BID):

The aim of the BID is to:

- Provide an overview of the Environmental Authorisation Process which will be undertaken for the proposed Atoll Modderfontein Prospecting Right in terms of the Mineral and Petroleum Resources Development Act (MPRDA, Act 28 of 2002, as amended) and the National Environmental Management Act (NEMA, Act 107 of 1998).
- Allow I&AP's the opportunity to obtain a broad understanding of the proposed project as well as register and submit any initial comments or concerns with regard to the proposed project.
- Notify I&AP's of the compilation of a Basic Assessment Report (BAR) which will address all comment received and in turn will be submitted to the Relevant Authority for decision making.

LOCATION, SCALE, AND EXTENT OF THE PROPOSED PROJECT:

The proposed Atoll Modderfontein Prospecting Right area is located over a portion of portion 1 of the farm Modderfontein 761R which is located approximately 5 km east of Benoni and 5 km north of Brakpan, in Gauteng, South Africa. The application area being applied for (or area of interest) is approximately 86.55 ha in extent. A locality map is included as Figure 1.

PROJECT DESCRIPTION:

The applicant has applied for a prospecting right that will enable them to ascertain if economically viable deposits of aggregate (Quartzite, conglomerate, diamictite, sandstone) and dolomite exist within areas applied for. The area is disturbed by previous mining activities. Due to the nature of data collection and the historical borehole datasets, no invasive sampling/drilling will be necessary. As such there will be no disturbance on the land as a result of the proposed prospecting right.

The application will follow a phased approach, where the prospecting work program is divided into several sequential phases. At the end of each phase there will be a brief period of compiling and evaluating results. The results will not only determine whether prospecting proceeds, but also the manner in which it will go forward. The applicant will only action the next phase of prospecting, once satisfied with the results obtained in the previous phases.

The project will therefore only include the following non-invasive activities:

Data Collection and Literature Survey

The proposed prospecting area is known to have detailed borehole drilling over the area. The literature survey will involve the gathering of existing information in the form of historical borehole information, cadastral maps, geological maps, and geophysical surveys. Furthermore, the information pertaining to previous exploration or mining will be consulted and integrated.

Data Capture, Database Development

The data collected during the first year will be collated and captured in a database for use in spatial mapping (GIS) and modelling of the geological resource.

Topographical/Geophysical Survey

Cadastral surveys of the surrounding areas will be obtained from the Surveyor General's Office, as a benchmark for locality reference. The topography of the prospecting Right Area will be surveyed to determine the original ground level (OGL), positions of historic prospecting; the locality of historic waste rock dumps and their dimensions will be determined

to obtain 3-dimensional points for accurate calculations. The surveys will include the positions of previously drilled borehole/test pits emanating from past exploration of the area.

Resource Modelling

A 3-dimensional geological model will be constructed from which the extent of the resources can be determined. This would reveal the volume of suitable aggregate, dolomite and topsoil within the area.

DURATION OF ACTIVITY:

The Atoll Modderfontein Prospecting Right is scheduled to take place over 5 years.

NEMA LISTED ACTIVITIES APPLICATION:

The listed activities applied for under the NEMA process in terms of Government Regulation (GNR) (983), are as follows:

- Activities directly related to prospecting of a mineral resource, including the operation of that activity which requires a prospecting right in terms of section 16 of the Mineral and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002), including associated infrastructure, structures and earthworks.

TYPICAL IMPACTS ASSOCIATED WITH THESE ACTIVITIES:

Due to the availability of historical geological data, only non-invasive prospecting techniques will be utilized. Site access will only be required for the topographical and geophysical surveys. Potential impacts that may occur as a result of the proposed prospecting activities are:

- Potential for deterioration and damage to existing roads or access tracks;
- Safety and security risks to landowners and lawful occupiers;
- Interference with existing landuses; and
- Generation and disposal of waste.

The above potential impacts, although unlikely, have been identified as possibly occurring when the site is accessed to undertake topographical and geophysical surveys. Should such impacts occur, they would however be of very limited significance due to their non-invasive nature. The identified impacts shall however be assessed in detail during the compilation of the Basic Assessment Report (BAR) which shall also include appropriate avoidance and mitigation measures. The compilation of the BAR shall also take into account the results of consultation with I&AP's.

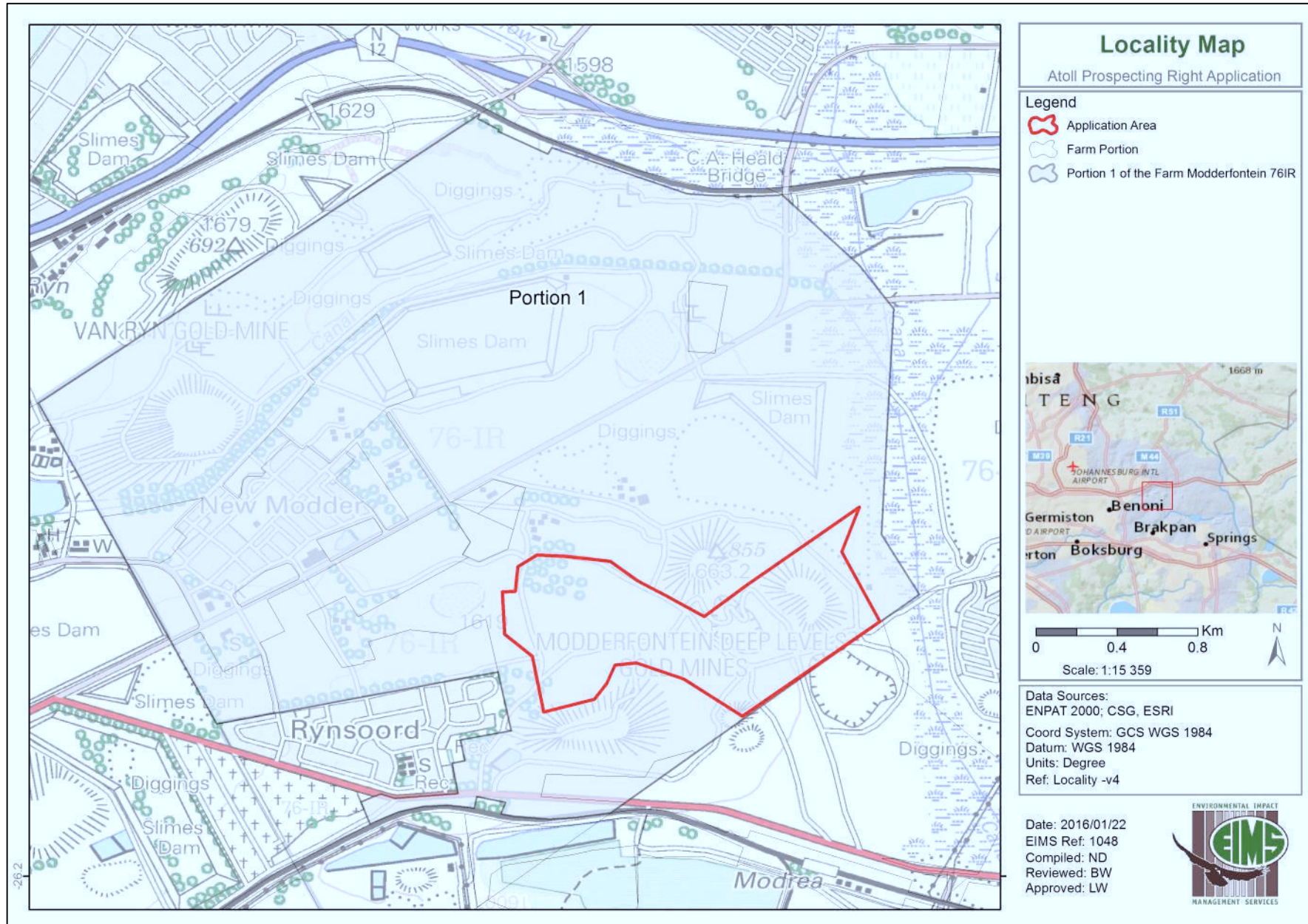


Figure : Locality Map
