Morning Aluwani and Tebo

Thank you very much for making the time to see both us and the applicant last week. Your input is greatly appreciated.

Below please find a summary of the agreed upon way forward with regards to amending the EIR with the inclusion of information required by the department.

1. Inclusion of a geotechnical specialist study and the recommendations stemming from it into the EIR; **(we need have mining issues affecting the development, including recommendation and conclusions)**
2. Submission of the geotechnical specialist study to the Council of Geoscience for comment – do note that it is unlikely that the council will comment on the report as the project is not located within a dolomitic area; **The council for Geoscience must be provided with opportunity to comment. If they refuse, the the refusal to comment must attached. Our primary requirement is that the Council for Geoscience must comment on the interface between the previously mined area and the current proposal to develop a Mixed use development that includes residential.**
3. Removal and rehabilitation of the three tailings on site including an assessment of the impact of the larger tailings related to its removal schedule and the delineation of a suitable buffer from the development; **how the removal of the tailing will be done and the logic underlying the phasing approach of the removal must be reported on**
4. Inclusion of an updated air quality specialist study and the recommendations stemming from it into the EIR; **correct but this must also include wind dispersal of the dust against prevailing wind directions. This must also inform the proposed buffers**
5. Inclusion of NNR clearance; **correct**
6. Revised layout plan superimposed on a consolidated sensitivity map. **Correct**

All of the above components will then be distilled into a revised EIR which will be submitted. Please confirm that you are in agreement with the above scope of work?

Lastly, the applicant will apply for an extension for the submission of the EIR citing undertaking the above tasks as the reason for it. The extension application request will be submitted to Boniswa Balot of GDARD – please could you provide me with her email address? **Boni is copied in email, you can send an extension request to her**
