He smiles enthusiastically as he talks about the players.

"They will always greet me when they see me with a 'hey Don, how are you?' and a hug or a high five. That is one of the biggest reasons why I am an Aces fan."

A true supporter will remain loyal no matter what happens on the pitch. And Don Mnisi will always be in the stands with his Aces shirt.
