**APPLICATION FOR PROSPECTING RIGHT IN TERMS OF SECTION 16 IN TERMS OF  
THE MINERAL AND PETROLEUM RESOURCES DEVELOPMENT ACT, 2002 (THE  
ACT) (AS AMENDED PORTIONS 9, 10, 11, 14, 23, 24, 210 AND 211 OF THE FARM  
ROODEPOORT 504 JR: IN THE MAGISTERIAL DISTRICT OF BRONKHORSTSPRUIT.**

1. This is to inform you that your application for a prospecting right in terms of section 16 of the Act to prospect **coal** in respect of the abovementioned property has been accepted.
2. You are therefore required in terms of section 16 (4) (b) as amended by section 12 of the MPRDA Amendment Act read with Regulation 52 (1) of the Act to:
  - 2.1 consult in the prescribed manner with the landowner, lawful occupier and any interested and affected party and include the result of the consultation in the relevant environmental reports.
3. The Minister has, after having had regard to and considered the type of mineral that you applied for and the extent of your proposed prospecting activity decided to direct you to give effect to the objects of section 2(d) of the MPRDA. You are therefore directed to submit the following documents within **60 days** from the date of this letter, namely;

- a. Share certificates;
  - b. Details relating to the equity by the BEE shareholders;
  - c. Any other agreement relating to the BEE shareholding including the voting pool agreement where applicable; and
  - d. Your articles and memorandum of association.
4. Acceptance of your application does not grant you the right to commence with any prospecting and/or mining activities. It only signifies that your application will be processed in order for the Minister or his delegate to consider same and make a decision within **197** days from the date of acceptance of your application.
