Obama unveils clean power plan to fight climate change

LONDON: Hoping to position the US to take the lead in global negotiations later this year to combat climate change, President Barack Obama unveiled a bold plan yesterday to slash emissions of carbon dioxide from power stations at home by almost a third within 15 years.

Detailing the new regulations, dubbed America's "Clean power plan", Obama asserted that "no challenge poses a greater threat to our

future, the future generations, than the changing climate". He warned: "We only get one planet; there is no plan B." He noted that hitherto the federal government had never attempted to curb CO₂ from power plants.

"This is one of those rare issues, because of its scope, that, if we don't get it right, we may not be able to reverse; we may not be able to adapt sufficiently," Obama said. "There is such a thing as being too late when it comes to climate change... The science tells us we have to do more."

The landmark proposal, the biggest climate change measure ever attempted by the US, triggered an instant political and legal backlash as several states prepared to challenge the rules in the courts and Republican presidential runners accused Obama of declaring war on the already beleaguered coal sector.

It means that climate change will take centre stage in the coming presidential election. In 2012, it barely featured. Hillary Clinton, the leading Democratic candidate, had already stated her support for

the emissions plan.

"It will need defending. Because Republican doubters and defeatists - including every Republican candidate for president - won't offer any credible solution," she said.

Whereas an earlier version of the plan required a 30 percent nationwide cut in carbon dioxide emissions by 2030, compared to 2005 levels, the final iteration toughens that target to 32 percent. Unchanged is the pledge Obama will take to final negotiations for a global UN treaty on climate change in Paris in December to cut over-

all emissions from all sources of pollution by 26 to 28 percent by 2030.

The UN Secretary General Ban Ki-moon lauded the "visionary leadership" of Obama. "We believe that this plan shows the US' determination to address global warming while also saving money and growing (economically)," Stéphane Dujarric, Ban's spokesperson, said. The power-plant rules as written would force US energy companies to retire hundreds of coal-fired plants across the country, a potentially devastating blow to

the coal sector. States with big coal interests are set to lead the effort to derail them.

The plan also puts an expanded emphasis on renewable sources of energy in place of coal and increasingly also of natural gas, putting the US on course to derive 28 percent of its power from sources such as solar and wind by 2030, compared to 22 percent in an earlier draft. A New York Times poll conducted in January suggested that two-thirds of Americans are likely to favour politicians willing to address climate change.

Christians held for alleged crimes

Chinese police have detained seven members of a Christian church for suspected crimes including embezzlement, state media and one of their lawyers said yesterday after they resisted a government campaign to take down their church's cross.

The Xinhua state news agency said the seven were detained on suspicion of amassing large amounts of money from running the church, embezzling donations and instigating others to disrupt the social order.

5 arrested for trafficking women

Thailand has arrested five people suspected of trafficking Thai women into sex slavery in China and believed to be part of a ring that has also trafficked women into Malaysia and Singapore, Thai police said yesterday.

The arrests come a week after the US kept Thailand on its list of the worst human trafficking centres. The Thai government has said it hopes the US will remove it from the blacklist following a crackdown.

2 000 migrants die en route to EU

More than 2 000 migrants and refugees have died this year trying to cross the Mediterranean Sea to reach Europe, the International Organisation for Migration (IOM) said yesterday.

The death toll is about 25 percent higher than during the same period last year. Migrants have been arriving in Greece and Italy by boat in roughly equal numbers, but nearly all of the deaths since January have occurred on the route from Libya to the Italian island of Sicily.

Stewart steps away from comedy gold as US election heats up



Heartbroken fans are wishing Jon Stewart a "jon voyage" on Twitter, but Donald Trump and the other 2016 US presidential candidates may be breathing a sigh of relief.

Stewart steps down from *The Daily Show* tomorrow after 16 years of biting political and media satire just as the presidential election campaign, a comedy gold mine, heats up.

Trump, the billionaire businessman-turned-Republican White House contender, has become Stewart's favourite target as his tenure on the popular Comedy Central programme winds down.

"Donald Trump is the candidate version of the hot dog-crust pizza," Stewart said last month. "You don't want it, you never ordered it. You can't believe someone came up with it. But now it's all you want to eat."

Stewart, who is widely credited with having transformed US political comedy, has dubbed next year's elections "Democalypse 2016". He told Britain's Guardian newspaper in April that he was weary after covering four previous elections and "it didn't appear that there was going to be anything wildly different about this one".

French police free Gabon official

French police have released the chief of staff of Gabon's President Ali Bongo who was detained for questioning in a corruption probe after the foreign ministry said he had diplomatic immunity, a judicial source said yesterday.

Monday's arrest of one of Gabon's most influential and controversial figures, Maixent Accrombessi, had been sharply condemned by Libreville, stoking tensions between the oil-rich Central African country and France.

US may help fight Boko Haram

The US could lift a ban on shipping arms to Nigeria's military to help fight the militant Islamist group Boko Haram if Abuja improves its human rights record, visiting US Congress members said yesterday.

They said Washington would provide more support for the fight against the group, which has killed thousands of people in its drive to set up an Islamic state in north-eastern Nigeria, if alleged abuses are investigated and perpetrators punished.

The military has been accused of violating human rights while trying to defeat the Boko Haram insurgency.

Myanmar appeals for aid after floods

YANGON: Myanmar said yesterday it had appealed for international assistance to help provide food, temporary shelter and clothing for more than 210 000 people affected by widespread flooding following weeks of heavy monsoon rains.

At least 47 people have died in the floods, according to the government.

Myanmar's call for international aid stands in sharp contrast to the stance taken when it was ruled by generals.

The junta had refused outside help in the wake of a devastating cyclone in 2008, when 130 000 people perished in the disaster.

TORTURED INTO CONFESSING TO MURDER, SAY LAWYERS

Man executed despite outcry

ISLAMABAD: Pakistan yesterday hanged a man whose case triggered an international outcry because his lawyers said he was arrested as a juvenile and tortured into confessing to murder.

Pakistan has hanged nearly 200 people since December, when a massacre by militants at a school in the city of Peshawar prompted the government to lift a de facto ban

on capital punishment.

Only Iran and China have executed more people than Pakistan this year, says human rights group Amnesty International.

"Shafqat Hussain was this morning executed in Pakistan, despite widespread calls, both within and outside the country, for a stay," legal aid group Justice Project Pakistan, which was representing Hussain, said.

Pakistani law does not allow the execution of some-

one arrested as a juvenile.

State prosecutors said Hussain was an adult working as a watchman when he was arrested.

Lawyers for Hussain said school records showed he was 17 in 2004 when he was burnt with cigarettes and had fingernails removed until he confessed to killing a child.

His family have said he was 14; lawyers said the family did not keep records regarding Hussain's birth.

David Griffiths, Amnesty

International's South Asia research director, said the execution marked a "deeply sad day for Pakistan".

"A man whose age remains disputed and whose conviction was built around torture has now paid with his life," he said.

Police denied that Hussain had been tortured.

"A competent court has gone through Hussain's case at length and torture allegations were never proved," police spokesperson Qamar Zaib

Satti said.

Lawyers say the justice system is deeply flawed and few police are trained to conduct investigations.

Defence lawyers, appointed by courts for those too poor to pay, often do not show up and accusations of confessions extracted through torture are common.

Hussain's family says that is what happened to him.

Their mother said the family was too poor to pay a private lawyer.

South China Sea talks: Philippines backs US

KUALA LUMPUR: The Philippines will back a US call to halt land reclamation in disputed areas of the South China Sea, the country's foreign minister said yesterday, despite China's insistence that the issue should not be raised at an upcoming meeting.

Foreign Minister Albert Del Rosario said the Philippines was ready to help de-escalate tensions in the disputed region, if China and other claimant states agreed to be

bound by the same conditions.

Del Rosario added that the Philippines planned to discuss the topic at the 48th Asean (Association of Southeast Asian Nations) Foreign Ministers' Meeting, which kicked off in Kuala Lumpur yesterday.

His comments come a day after China said it did not want the theme discussed at the Asean's gathering.

Neither China nor the US are members of the regional body, but both will be repre-

ented during several days of talks in the Malaysian capital. US Secretary of State John Kerry will be in Kuala Lumpur today and tomorrow.

"The Philippines fully supports and will pro-actively promote the call of the US on the 'three halts': halt in reclamation, halt in construction, and halt in aggressive actions that could further heighten tensions," Del Rosario said.

"We will agree to be bound only if China and other

claimant states agree."

Though not on the official agenda, the South China Sea is among key topics likely to be discussed at the meeting, amid a backdrop of tension.

China claims most of the South China Sea, through which \$5 trillion (R63 trillion) in ship-borne trade passes every year.

The Philippines, Vietnam, Malaysia, Taiwan and Brunei have overlapping claims. - Reuters

262kg of elephant tusks seized, three Chinese men arrested

VIENNA: Elephant tusks weighing 262kg were seized at Zurich Airport before they could be shipped to China, the world's largest ivory market, Swiss customs officials said yesterday. At least 40 elephants were killed to acquire the tusks, which have an estimated black-market value of 400 000 Swiss francs.

The contraband ivory was found in early July stored in several suitcases that three Chinese couriers had brought from Dar es Salaam in Tanzania to Zurich. The men were apprehended as they were about to board a plane to Beijing.

Besides this record ivory find at Zurich Airport, customs officials have detected smaller shipments hidden in cosmetic cream jars in past weeks. "There is apparently an effort

to open a new ivory trade route via Zurich at the moment," said Heinz Widmer, the customs chief.

Ivory trade is banned under the Washington Convention, which aims to protect endangered animals and plants. While Dar es Salaam is known as a major hub for the ivory trade, China is the biggest market.

Poaching of rhinos and elephants has reached critical levels, leading to the possibility of extinction. An estimated 30 000 elephants are killed for their ivory each year.

The three Chinese suspects were initially detained but were granted bail worth 100 000 francs.

They face Swiss fines of up to 40 000 francs each, but Widmer said the men would probably face more severe punishments in China. - dpa

Further beautification of Lemm's Corner is coming to fruition, thanks to several pledges for benches and trees that have been made.

Preparations are underway for five mature trees to be planted, but creating the holes is no easy task however, says Elizabeth du Toit, manager of the Old Harbour Museum.

"Big rocks have to be removed! The original plan was to 'blast' the rocks, but the contractor is now looking at the possibility of using chemicals to create the 1.5 m holes that must accommodate the roots of mature trees."

Although no decision has yet been made on the trees to be planted, Du Toit assures that they will be indigenous. "We are still deciding if all the trees must be the same type, or if different kinds of trees must be planted. Either way, we would like the trees to attract birds."

Five people have made pledges so far that will provide for three handmade wooden

Several fish were added to the water feature by Anton and Nicole Verhoogt, owners of Fisherman's Cottage Restaurant who also sponsored the soil, compost and plants for the herb garden. The restaurant maintains the garden and makes use of the harvest. New plants will be added next month for the summer harvest.

Du Toit also praises local businesses on Lemm's Corner who have upped the ante and upgraded their shop fronts. Sidewalk Boutique has installed a glass window and Rossouw Modern has made a garden before their gallery.

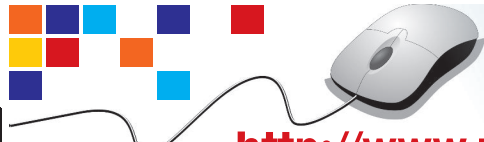
