In our records there is no land claim lodged on the farm Geluk 512 KS and Geluk Oos 513 KS, however, note that the Lodgement process of Land Claims has been re-opened until the year 2019, therefore there might be land claims lodged in the future.


Kindly note that there are four land claims lodged on the farm Ironstone 847 KS as follows: Mogaswa Manamane Tribe (KRP 1851/2497), Bahlakwana Ba Maphopha (KRP 1552), Tau Nkadimeng - Manganeng (KRP 2542), Bakwena Ba Makua Tribe (KRP 1642) and Manganeng Tribe (KRP 2542). The claims were gazetted on the 3<sup>rd</sup> of March 2006, Notice No. 368 of 2006 and 4<sup>th</sup> of May 2007, Notice No: 505 of 2007 respectively.
