Good afternoon,

The Heritage Free State Provincial Heritage Authority has not been assessed as competent to process development applications in terms of section 38(1) or 38(8). SAHRA processes these applications on the PHRAs behalf.

The SAHRIS application does act as a NID as part of a 38(1) application, however additional information regarding the proposed development can be uploaded. However, the SAHRIS application serves both the 38(1) and 38(1) process, and the SAHRIS application must be completed as part of a 38(8) application. When a 38(8) application is being undertaken, the EIA documents must be submitted so that an informed comment can be issued as the HIA will not contain all information regarding the development. I understand that there are discrepancies and confusion regarding the two processes and we are working on rectifying this through an update to the SAHRIS interface that will hopefully roll out near the end of the year.

In conclusion, SAHRA processes all development applications in terms of section 38 located in the Free State and an application must be made on SAHRIS for both processes.

Good Afternoon Natasha,

I trust this email finds you well.

SLR are in the process of compiling a DFFE application for EA form for a project in the Free State province and came across the following statement:

*"If Section 38 of the National Heritage Resources Act (Act No. 25 of 1999) is applicable to your proposed development, you are requested to submit the Notice of Intent form to the relevant SAHRA or a Provincial Heritage Resources Authority and attach a copy to this form."*

In light of this, could you please confirm whether the Free State Heritage Resources Authority (FSHRA) are competent to perform all functions of the NHRA and whether section 38(1) and 38(8) applications in the Free State are processed by the FSHRA or whether SAHRA will be the commenting heritage authority?



Based on previous correspondence with SAHRA, it was advised that only developments that are applied for in terms of section 38(1) of the NRHA require that the relevant Heritage Resources Authority is notified at the earliest phase via a NID document. If an application to SAHRA is submitted via the South African Heritage Resources Information System (SAHRIS), the SAHRIS application acts as a NID document. Additionally, if the application is being conducted in terms of section 38(8) of the NHRA, then no NID is required as 38(1) does not apply when a 38(8) process is undertaken. As such, a NID is not required if the application is being conducted in terms of section 38(8) of the NHRA. A case application must however be created on SAHRIS and will act as a NID document.

Therefore, should SAHRA be the commenting heritage authority, a case application will be created on SAHRIS and will act as a NID document. Could you please confirm this?
