A fire destroyed NicReg, a popular pub, grill and accommodation venue at Tshirolwe in
Nzhelele last Tuesday (2nd). The damage to the buildings and the furniture is estimated at more than R2,6 million.
In an interview with Limpopo Mirror, NicReg's co-owner, Mr Reggie Mathivha, said that he was not sure what had caused the fire as he had not been around when the incident happened. The fire apparently broke out in the early morning hours. People who were sleeping in the back rooms were awakened by guards warning them that the pub was on fire. The police and firefighters were immediately alerted about the incident.
"The whole thing is still under investigation," he said. "It is a big setback and hopefully in time things will be fixed.' In a Facebook pos after the incident Reggie wrote: "The en trepreneurship dream is reduced to ashes for now.
