



Slovo residents protest

Slovo Park - Protests broke out in Slovo Park last Tuesday and Wednesday.

The community was allegedly protesting for jobs at a nearby coal company.

The road was closed on Wednesday morning as the protesters were burning tyres and hurling stones at cars.

By Wednesday, the situation

had calmed down, but there was still heavy police presence on the road.

The traffic lights at one of the intersections were also damaged overnight.

Ward Clr Dean Stone says: "While I respect people's right to protest, they should not damage municipal property."

Springs police spokesperson

Capt Johannes Ramphora has similar sentiments and condemned road closures and the damage to people's cars.

"There was a criminal element by some during the protests which led to looting at several spaza shops.

There are a few cases that have been opened and the police will be doing a thorough investigation," says Ramphora.

The Addie has heard rumours of a meeting scheduled between the community and management from the coal company, but we have not been able to confirm this as the company did not respond to our requests for comment.

We will publish more information as it becomes available.

Beaten to death

Duduza - Siyabonga Mavuso (25) was killed by an angry mob last Wednesday afternoon.

Mavuso was later seen walking back towards the man's home in Cool Breezy section, holding an axe.

Duduza SAPS communications officer Sgt Harry Manaka says the resident, out of panic, blew a whistle to alert the community to the danger.

"The community then chased Mavuso until they caught him and beat him up with sjamboks until he died," he says.

Manaka says the suspects have been arrested and detained while the deceased's body was taken to the Heidelberg Government Mortuary.

"They will appear in the Nigel Magistrate's Court on charges of murder," he adds.

1 INTRODUCTION

Wozimart (Pty) Ltd (hereafter the applicant) has appointed Enviro-Insight CC as the Environmental Assessment Practitioner (EAP) to undertake an Environmental Authorisation (EA) associated with the proposed Welgedacht Prospecting Right (PR) Application on an area of approximately 771 ha. An application for a PR was lodged by Wozimart (Pty) Ltd with the Department of Mineral Resources (DMR) on 4 September 2018, reference number GP30/5/1/1/2/ (10553) PR, and was accepted in terms of section 16 of the Minerals and Petroleum Resources Development Act, 2002 (MPRDA, as amended) on the 1st of October 2018. A 50 day extension period was requested from the DMR on 11 December 2018 which was granted. 


Figure 2-1: Locality map of the study area indicating nearest towns and main roads.




Figure 2-2: Locality map indicating farm portions applicable to the application.




Figure 2-3: Plan contemplated in regulation 2(2) showing the land to which the application relates.

4 LEGISLATIVE PROCESS

The applicant is required to submit an application for a prospecting right in terms of Section 16 of the Mineral and Petroleum Resources Development Act, 2002 (Act 28 of 2002) with the DMR. In support of the application to obtain the prospecting right, the applicant is required to conduct a Basic Assessment (BA) process that needs to be submitted to the DMR for adjudication, which includes activities triggered under the Environmental Impact Assessment Regulations of 2014 (as amended) promulgated under the National Environmental Management Act, 1998 (Act 107 of 1998).

The proposed prospecting right constitutes various listed activities which have been listed within the scheduled activities of Listing Notice 1 and 3 in Government Notice Regulation No 324, 325 and 327 (2014 EIA regulations as amended on 7 April 2017) and therefore require a Basic Assessment (BA) process to be followed. Prior to any listed activity being approved by the DMR, it is required that an environmental authorisation process is undertaken and a report is submitted to the relevant environmental authority for consideration.

The purpose of the BA process is to ensure that potential environmental, economic and social impacts associated with operation and closure/ rehabilitation of a project are identified, assessed and appropriately managed.

The requirements for the BA process are specifically contained in Chapter 4 Part 2 and Appendix 1 of the NEMA Reg No 326 (amended on 7 April 2017). According to Section 19 (3) of GNR No 326: "...where the application for an environmental authorisation is for prospecting, exploration, or extraction of a mineral or petroleum resource, including primary processing, or activities directly related thereto, the basic assessment report must address the requirements as determined in the regulations, pertaining to the financial provision for the rehabilitation, closure and post closure of prospecting, exploration, mining or production operations, made in terms of the Act."

The BA process can take up to 90 days to complete from submission of application to the final submission of the BAR to the DMR. The competent authority must within 107 days of receipt of the BAR in writing confirm whether the EA application has been granted or refused.

5 SPECIALIST STUDIES

Proposed specialist studies to assess the environmental impacts during the BA process:

- Wetland Delineation;
- Terrestrial Ecology Assessment; and
- Heritage Impact Assessment.

These studies will form part of the impact assessment in the BAR and the information used to be included in the environmental management programme (EMPr).

6 PUBLIC PARTICIPATION PROCESS (PPP)

6.1 OBJECTIVES OF PUBLIC PARTICIPATION

- Provides an opportunity for I&APs, EAP and the Competent Authority (CA) to obtain clear, accurate and understandable information about the environmental, social and economic impacts of the proposed activity or implications of a decision;
