



## Hartbeespoortdam NSRI divers and SRU offer assistance to find missing 9-year-old

**BRITS POS – MADIKWE –** In a multi-disciplinary search and rescue operation in Uitkyk Village, Madikwe, members from the National Sea Rescue Institute (NSRI) and Strategic Response Unit (SRU), Police Air Wing, divers and community members, all lent a hand in finding the body of a 9-year-old boy.

The boy and friends were playing in a stream near their village late on Friday afternoon, 7 January 2022, when the boy jumped in for a swim, but was swept away by the fast current of the river. The victim's friends alerted the victim's parents, who immediately informed Madikwe police. Shortly after a search was conducted, but unfortunately, as it was getting dark, had to be called off, but resumed early on Saturday morning.

All the role players were activated and Hartbeespoortdam NSRI divers and SRU offered their assistance. The search continued until around 17:30 when members from the police Air Wing spotted the body of the child stuck in the debris. The NSRI and SRU members from Hartbeespoort retrieved the body of the child from the river.

Brigadier Reginah Ntoagae has commended the role players as well as the community for their efforts in ensuring that the body of the child was found. She conveyed her condolences to the family of the deceased.

## Suspect arrested and one fatally wounded in shootout with police

**BRITS POS – OUKASIE –** A male suspect was arrested and another fatally wounded during a shootout with police who responded to a business robbery in Oukasie, Brits on Monday, 20 December 2021.

It is alleged that a bottle store manager (31) in Masenkeng Section, was struck in the face with a firearm by one of the two armed suspects who entered the store at about 10:30 and then fired one shot and instructed the victim to lie down.

A 38-year-old suspect, Mlungise Thusi (28) appeared before the Brits Magistrates' Court on Wednesday, 22 December 2021, but is still in custody. His next appearance is Friday, 21 January 2022. According to Captain Aafje Botma, spokesperson for the SAPS Northwest, no further arrests have been made yet.

Ouma Nora, soos almal haar ken, is in 1910 in Rustenburg gebore en het in haar kinderjare na Brits en later Damonsville verhuis.

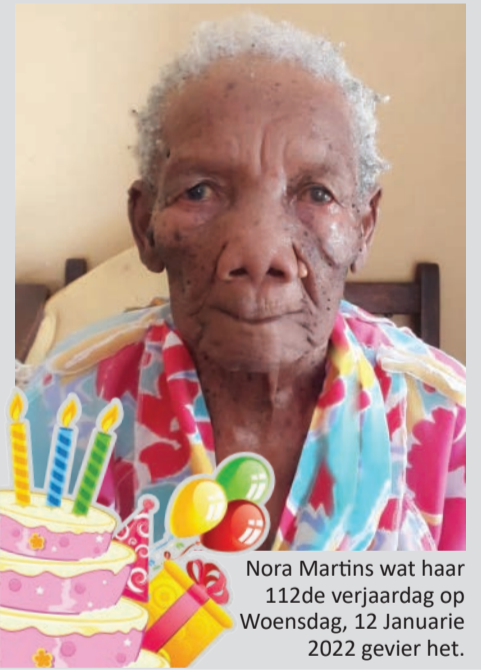

Op die vraag hoe 'n mens voel om die lewe met al die veranderings oor 'n eeu en meer as 'n dekade te ervaar, het sy met helderheid van verstand en 'n glinster in die oë gesê dat dit baie opwindend was. "Met al haar kennis is sy 'n lopende biblioteek," sê Sonja.

Gedagtig hieraan was ouma Nora maar net 'n klein dogtertjie toe die 1ste Wêreldoorlog (1914-1918) gewoed het, sy was in haar 40's toe die Voortrekkermonument (1937-1949) gebou is en sy was al bykans 60 jaar oud toe die eerste man op die maan geland het.

Voorwaar 'n merkwaardige mylpaal! Sy word hartlik gelukkiggewens. God's rykste seën, goeie gesondheid en vreugde word haar toegewens.
