NORTH WEST REGION.

included in the final amendment EIAR/EMPr to be submitted to this office for

processing further.

b) EIAr/EMPr must be comply with the requirements as stipulated on appendixes 3

and 4 of the EIA regulations: 2014.

c) You are required to determine the amount of financial provision as required in

terms of section 24P of the National Environmental Management Act, 1998 (Act

No. 107 of 1998) for the rehabilitation, closure and ongoing post decommissioning

management of negative environmental impacts.

d) All maps must be provided in A3 paper size and must be have a legend and

printed in colour.

4. You are required to submit 3 (three) hard copies of the EIAR/EMPR together with all

the above-mention information to this office within 106 days of the signature of

acceptance of the Scoping.

5. Take note further that in terms 45 of the EIA regulations: 2014 failure to submit the

EIAR/EMPr as requested and failure to adhere to the timeframes as stipulated shall

results in your application being considered as having lapsed.
