#### Dear Stakeholder

This letter serves to notify you, as a potential interested and affected party (I&AP), that TotalEnergies EP South Africa B.V. (TEEPSA) together with its joint venture partners, QatarEnergy, CNR International (South Africa) Limited, and a South African consortium, MainStreet 1549 is applying for a Production Right in terms of Sections 83 to 86 of the Mineral and Petroleum Resources Development Act, 2002 (Act 28 of 2002) (MPRDA) (as amended). The Production Right application is to allow for the development and production of gas and associated condensate in Licence Block 11B/12B, offshore from the Southern Cape coast, South Africa.

As part of the Production Right application process, an application for an Environmental Authorisation (EA) in terms of the National Environmental Management Act, 1998 (Act 107 of 1998) (NEMA) (as amended) must also be submitted. The application for EA must be supported by a Scoping and Environmental Impact Assessment (S&EIA) process in accordance with the Environmental Impact Assessment (EIA) Regulations, 2014 (GN R.326), as amended. The EA application must be submitted to the Petroleum Agency of South Africa (PASA) for a recommendation to the Minister of Minerals and Energy, who will decide on whether to grant the Production Right and EA.

TEEPSA has appointed WSP Group Africa (Pty) Ltd as the independent Environmental Assessment Practitioner to undertake the ESIA and public participation process.

The Draft Scoping Report is available for public review from **Thursday 01 December 2022** until **Friday 03 February 2023**.
