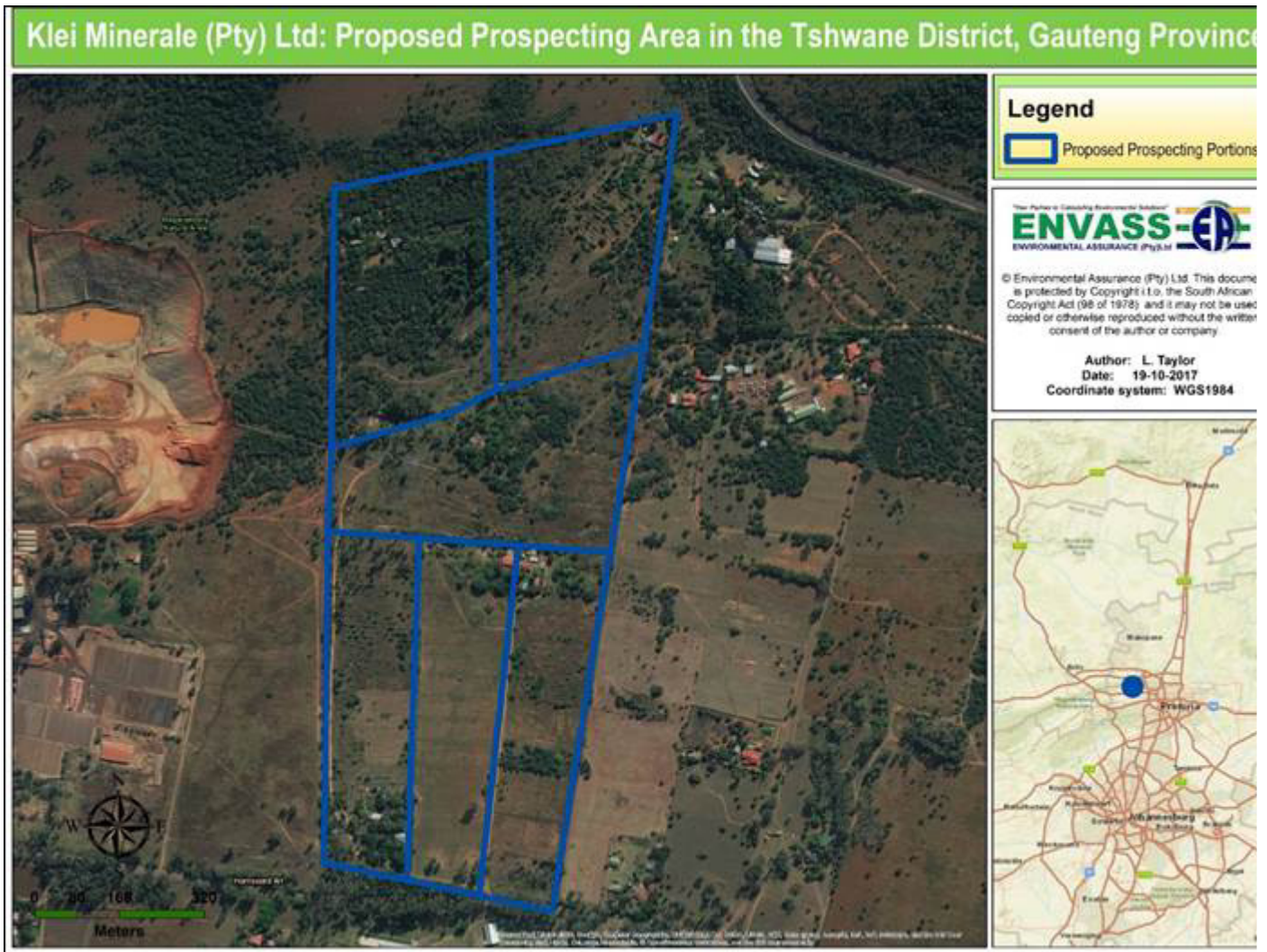

Notice is hereby given of a Public Participation Process in terms of the National Environmental Management Act No. 107 of 1998 (as amended) (NEMA) for the proposed prospecting by Klei Minerale (Pty) Ltd on Portions of the Farm Boekenhoutkloof 315 JR, Gauteng Province.

**APPLICANT AND PROJECT DESCRIPTION:**

The Applicant, Klei Minerale (Pty) Ltd, has applied for a prospecting right in terms of section 16 of the Mineral and Petroleum Resources Development Act, No. 22 of 2002 ("MPRDA") and for an Environmental Authorisation for prospecting without bulk sampling. The type of minerals to be prospected for include: (CS) Shale/Brick Clay; (Cy) Clay (General); (Q) Silica Sand (General); (Qy) Sand (General) and (Rm) Aggregate.

The proposed prospecting will be conducted on Portions 36, 37, 38, 39, 40 and 41 of the farm Boekenhoutkloof 315 JR, Gauteng Province. The site is situated within the City of Tshwane Metropolitan Municipality, approximately 14 km north-west of Pretoria CBD. The total application area is 60,6998 hectares in extent. The **co-ordinates** are as follows: approximate centre of the site: -25.691573°, 28.064657°, Survey Datum: WGS84 Lat/Long Decimal Degrees. **Street Address:** Kenneth Street, off Hornsnek Road, Pretoria North.



The Public Participation Process will, in due course once the prospecting right application has been accepted by the DMR, also apply to the application for the prospecting right for purposes of and in compliance with section 16(4)(b) of the MPRDA.

**APPLICATION FOR LISTED ACTIVITIES PUBLISHED IN TERMS OF NEMA and the EIA Regulations, 2014 (as amended), GOVERNMENT NOTICE 983 [as amended in 2017]: Activity 20:**

Any activity including the operation of that activity which requires a prospecting right in terms of section 16 of the MPRDA, including—

- a) associated infrastructure, structures and earthworks, directly related to prospecting of a mineral resource; or
- b) the primary processing of a mineral resource including winning, extraction, classifying, concentrating, crushing, screening or washing; but excluding the secondary processing of a mineral resource, including the smelting, beneficiation, reduction, refining, calcining or gasification of the mineral resource in which case activity 6 in Listing Notice 2 applies.
