





Good day Councillor Willie Links and Councillor Ana Bock

(Ward 1 & 2- Richtersveld Local Municipality)

Our meeting at Port Nolloth on 1 December 2020 and telephone discussion on 2 December 2020 refers.

As discussed, Naledzi has been appointed by NDI Geological Consulting Services Pty Ltd to conduct an Environmental Impact Assessment Study for two alluvial diamond prospecting right applications on the Orange River near Sendelingsdrif. The applicant for the prospecting rights is Samara Mining (Pty) Ltd.

We initially scheduled four public meetings to be held in Sanddrif, Kuboes (3 Dec), Eksteenfontein and Lekkersing (4 Dec). These meetings have now been cancelled due to the risk of covid-19 in the Richtersveld area.

We will need to reschedule these public meetings for January 2021 and will need to provide the community with a different platform to receive information and submit comments. A short summary of my discussions with Councillor Links follows below. (Councillor Links please review and give inputs if any parts of the discussions were recorded incorrectly).

Discussion of 1 Dec 2020:

1. Willie Links (Councillor)

- a. There are no issues in Ward 1 which comprise the communities of Kuboes, Lekkersing, Eksteenfontein and Sendelingsdrif);
- b. The communities raised the following concerns:
 - i. Samara wants to mine within the Orange River and this might to several environmental impacts and destruction of the river and kill fish;
 - ii. Their livestock must drink from the river. How will prospecting on the river affect access for livestock to drink?
 - iii. What job opportunities will be created by the prospecting activities (incl. period) and how will Samara empower the people?
- c. Sanddrif falls within Ward 2 of Councillor Ana Bock. It came to our attention that the community in Sanddrif received incorrect information regarding the application and this has created confusion and dissatisfaction amongst members;
- d. Unemployment is a major issue in the Richtersveld, and Namakwa District for that matter. Job losses have increased over the last period.
- e. Samara has also indicated that they will host an Agriculture and Mining Summit for the communities in January - February 2021.

2. Marissa Botha (Naledzi)

- a. Samara Mining Pty Ltd has prepared a Social Development Plan in support of their Prospecting Right Applications and we would summarise this information and present it to the communities.
- b. We are aware of the planned Agriculture and Mining Summit planned for 2021;

- c. The public meetings with the communities need to be postponed until January 2021 and we need another platform to communicate with the community members directly;

3. Willie Links (Councillor)

- a. We have several ward committee groups namely Kuboes, Lekkersing and Eksteenfontein
- b. We will need to confirm with Ana Bock if there is a ward committee group for Sanddrif and get their contact details.
- c. We can communicate project information to members via a WhatsApp Group. We can send meeting notices, people can comment etc. This will help them to submit their concerns now that the meetings have been postponed.
- d. We can reschedule the public meetings to the week of 12 - 16 January 2021 and send out the notifications by 15 December 2020

4. Marissa Botha (Naledzi)

- a. The WhatsApp Group is an excellent idea.
- b. Naledzi will create the WhatsApp Group for the public engagement group;
- c. It will be important that the councillors send Naledzi the relevant contact details of the committee members and community members that need to be added to the WhatsApp Group. This will be required asap. (Willie Links agreed to provide the details by COB 2 Dec 2020).
- d. We will need to arrange SAPS presence for the meetings.

5. Willie Links (Councillor)

- a. Naledzi must engage with the SAPS (Port Nolloth and Alexander Bay) before 15 Dec 2020, notify of the meetings of January 2021 and arrange their presence
- b. Naledzi must arrange a quick dry run meeting on 11 Jan 2021 with the stakeholders (Municipal Manager, Mayor, councillors, Namakwa District and SAPS) before the public meetings
- c. The next day we go to conduct the public meetings in the four areas.

Way forward:


