Comrades Marathon 2013 launched

THE official launch of the 2013 Comrades Marathon took place at Sandown's Radisson Blu hotel.

The campaign unveiling of the 88th Ultimate Human Race, which will take place on 2 June 2013 was attended by the country's top runners and sporting personalities, including Comrades legend Bruce Fordyce, who won the race a record nine times.

Next year's race will be the challenging 'up-run', where runners will set off from Durban to Pietermaritzburg.

Comrades Marathon Association chairman Peter Proctor said, "We are very pleased and excited about our 2013 Comrades. There is no doubt in our minds that every single runner is 'ultraordinary' and lends a unique feature to South Africa's most famous road-running race."

Proctor added that the attributes of runners made the race all the more touching and a "true people-centred" event.

Unsurprisingly, the doping scandal surrounding 2012 winner Ludwick Mamabolo surfaced

during the launch, with general manager of the association Gary Boshoff saying that an investigation and tribunal inquiry was ongoing.

"We will wait for the outcome of these inquiries before any steps are taken. Until then, runner-up Bongumusa Mthembu will be the provisional winner of the race," said Boshoff.

The launch saw the announcement of over R3,2 million raised by the association being donated to six beneficiaries of its Amabeadibeadi charity platform.

The Community Chest, Pink Drive, the Sports Trust, Starfish-Greathearts Foundation, Wildlands Conservation Trust and World Vision South Africa will benefit. The limit for participants in the next edition of the race has been set at 18 000, with the official opening of entries beginning on 1 September until 30 November 2012.

Notice is given in terms of Regulations published in Government Notice No. R.543 in Government Gazette No. 33306 18 June 2010, under Section 54(c)(i) of the National Environmental Management Act, 1998 (Act No.107 of 1998), as amended [NEMA], that Huddle Investments (Pty) Ltd intends to undertake a development that will compromise of primarily Residential and Private Open Space components, with elements of Business.

The development is approximately 53 hectares in extent (excluding associated infrastructure), and will be located on proposed Portion 84 (a portion of the remainder) of the Farm Bedford 68 IR, Linksfield, City of Johannesburg Metropolitan Municipality (CJMM), Gauteng Province. The proposed site is bordered by Linksfield Road and Club Street. There are existing sewer, gas and potable water pipelines in close proximity to the site to which the proposed development will connect. A 11 kV underground powerline will also be constructed to connect the proposed development to the Alexandra Substation (in the north).

In terms of Government Notice No. 543 of NEMA, read with Government Notice No. 544 (Listing Notice No. 1: Activities 9, 10, 11 and 22), Government Notice No. 546 (Listing No. 3: Activity 14) and Government Notice No. 545 (Listing No. 2: Activities 1, 8 and 15) of NEMA a Scoping and Environmental Impact Reporting Process is required in order to obtain Environmental Authorisation from the Department of Agriculture and Rural Development (GDARD) for the abovementioned project.

In terms of Section 21 (c) and (i) of the National Water Act, 1998 (Act No. 36 of 1998), the proposed development and/or associated infrastructure (i.e. powerline, sewer and gas pipelines) may also require a Water Use License from the Department of Water Affairs.

The Draft Scoping Report for the project is available for public review and comment from Tuesday, 04 September 2012 to Monday, 29 October 2012 on SEF's website www.sefsa.co.za and at the Sandringham Library at Dan Pienaar Park in Athlone Ave, Sandringham (contact Winnie Tshabalala: 011 640 5676). The library is open from 10:00 – 17:00 Mondays to Fridays and 09:00 – 13:00 on Saturdays. Kindly note a public meeting will be held during the review period of the Draft Environmental Impact Report (EIR) scheduled for early 2013.
