Kennis geskied hiermee ingevolge die Nasionale Wet op Omgewingsbestuur, 1998 (Wet 107 van 1998) (NEMA) en die 2014 Regulasies op Omgewingsimpakstudie (OIS-regulasies) (Staatskennisgewing R982 van 2014, soos gewysig), dat **South Africa Mainstream Renewable Power Developments (Edms.) Bpk. (Mainstream)** beoog om een (1) Radiotoring, twee (2) 400 kilovolt (kV) kraglyne en een (1) 132kV kraglyn te ontwikkel wat by die reeds gemagtigde 132kV/400kV Hoofttransmissiesubstasie (HTS) (14/12/16/3/3/1/2460/AM1) en gemagtigde Kentani Groep fotovoltaïese (FV) sonkragprojekte sal aansluit. Die projek sal ook die herbelyning van agt (8) 132 kV kraglyne in die kragnetkonneksiekorridor, wat as deel van die Kentani-groepering gemagtig is, behels en sal voorsiening maak vir hierdie belyning in die nuwe gemagtigde HTS. Die beoogde projekterrein is sowat 2,5 km noordwes van die dorp Dealesville in die Vrystaatprovinsie en is geleë in die Sentrale Strategiese Transmissiekorridor (Staatskennisgewing No. 113 & 145 van 16 Feb. 2018 en 26 Feb. 2021, onderskeidelik).

Die beoogde Radiotoring, 132kV kraglyn en 400kV In-en-Uit kraglyne sal elf (11) van Mainstream se FV-sonkragprojekte, wat as deel van die Kentani Groep gemagtig is, bedien. Die beoogde Radiotoring sal binne die voetspoor van die gemagtigde 132kV/400kV HTS opgerig word, terwyl die kraglyne sal aansluit by die gemagtigde HTS sowel as die gemagtigde 100MW Kentani FV sonkragprojek. Die 132kV/400kV HTS ontwikkelingsvoetspoor en die 132kV en 400kV korridors (waarbinne die Radiotoring en kraglyne wat deel uitmaak van hierdie aansoek / BE prosesse geleë sal wees) het in April 2022 magtiging vanaf DFFE ontvang (DFFE Verwysingsnommer: 14/12/16/3/3/1/2460/AM1). Om tegniese redes is die gemagtigde 132kV en 400kV korridors egter nie geskik vir die aansluiting van die gemagtigde HTS by die nasionale kragnetwerk of die gemagtigde Kentani FV sonkragprojek (DFFE Verwysingsnommer: 14/12/16/3/3/2/724/AM3) aan die HTS nie. Bykomende klein gedeeltes van die korridors moet dus geëvalueer word om die tegniese veranderinge sowel as die bykomende Radiotoring te akkommodeer.

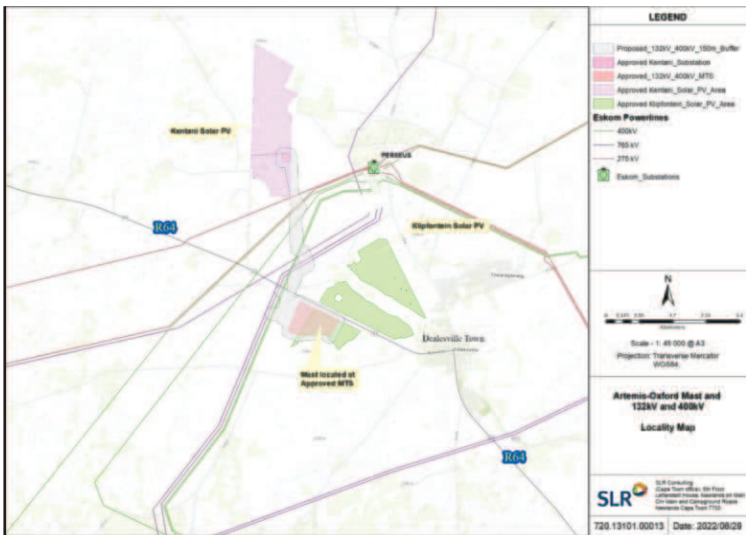

PROPOSED CONSTRUCTION AND OPERATION OF THE RADIO MAST, 132KV POWERLINE AND 400KV LOOP IN LOOP OUT (LILO) POWERLINE LOCATED NEAR DEALESVILLE IN FREE STATE PROVINCE**

Notice is hereby given in terms of the National Environmental Management Act, 1998 (No. 107 of 1998) (NEMA) and the 2014 Environmental Impact Assessment (EIA) Regulations (GN R 982 of 2014, as amended), that **South Africa Mainstream Renewable Power Developments (Pty) Ltd (Mainstream)** is proposing the development of one (1) Radio Mast, two (2) x 400 kilovolt (kV) powerlines and one (1) x 132kV powerline to connect to the authorised 132kV/400kV Main Transmission Substation (MTS) (14/12/16/3/3/1/2460/AM1) and authorised Kentani Cluster of solar photovoltaic (PV) developments. The project will also involve the re-routing of eight (8) 132kV powerlines within the grid connection corridor authorised as part of the Kentani Cluster and making provision for this routing in the new approved MTS. The proposed project site is located approximately 2.5 km north-west of the town of Dealesville, Free State Province, and is located within the Central Strategic Transmission Corridor (Government Notice No. 113 & 145 of 16 Feb 2018 and 26 Feb 2021 respectively).

The proposed Radio Mast, 132kV powerline and 400kV Loop in Loop Out (LILO) powerlines, will service eleven (11) of Mainstream's solar PV projects authorised as part of the Kentani Cluster. The proposed Radio Mast will be placed within the substation footprint for the authorised 132kV/400kV MTS, while the powerlines will connect to the authorised 132kV/400kV MTS as well as to the approved 100MW Kentani Solar Photovoltaic (PV) Energy Facility respectively. The 132kV/400kV MTS development footprint and the 132kV and 400kV corridors (in which the Radio Mast and respective powerlines which form part of this application / BA process would be situated) were granted authorisation by the DFFE in April 2022 (DFFE Reference Number: 14/12/16/3/3/1/2460/AM1). However, due to technical consideration, the approved 132kV and 400kV corridors are not suited to connect the approved MTS to the National grid nor the authorised Kentani Solar PV (DFFE Reference Number: 14/12/16/3/3/2/724/AM3) to the MTS, and as such additional small portions of the corridors are required to be assessed to accommodate the technical changes as well as add a new Radio Mast.

The proposed Radio Mast, 132kV powerline and 400kV Loop in Loop Out (LILO) powerlines, trigger activities in the 2014 EIA Regulations Listing Notices 1, 2¹ and 3 (GN R. 983, 984 & 985, as amended), as gazetted in terms of the NEMA. As such, the project requires Environmental Authorisation (EA) from the National Department of Forestry, Fisheries and the Environment (DFFE) which is subject to a BA process. One (1) application for EA will be lodged for the Radio Mast, 132kV powerline and 400kV powerlines and an integrated Public Participation Process will also be undertaken as part of the BA process.

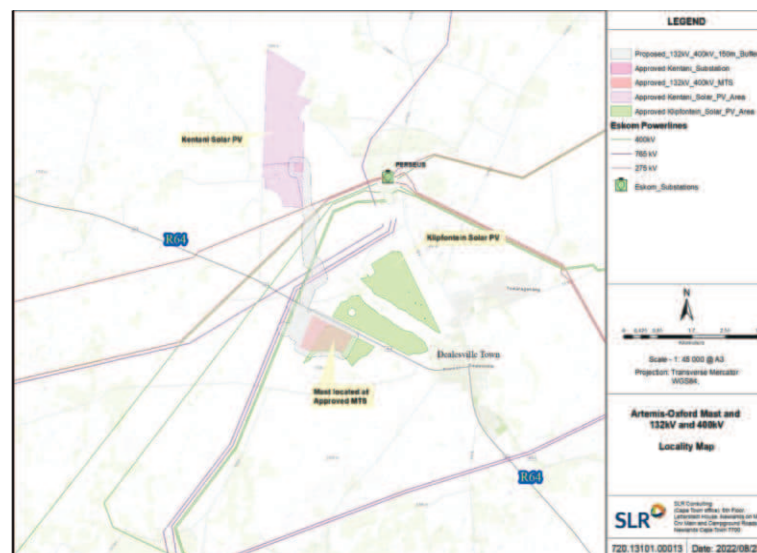


Figure 1: Radio Mast and 132kV and 400kV Infrastructure Locality

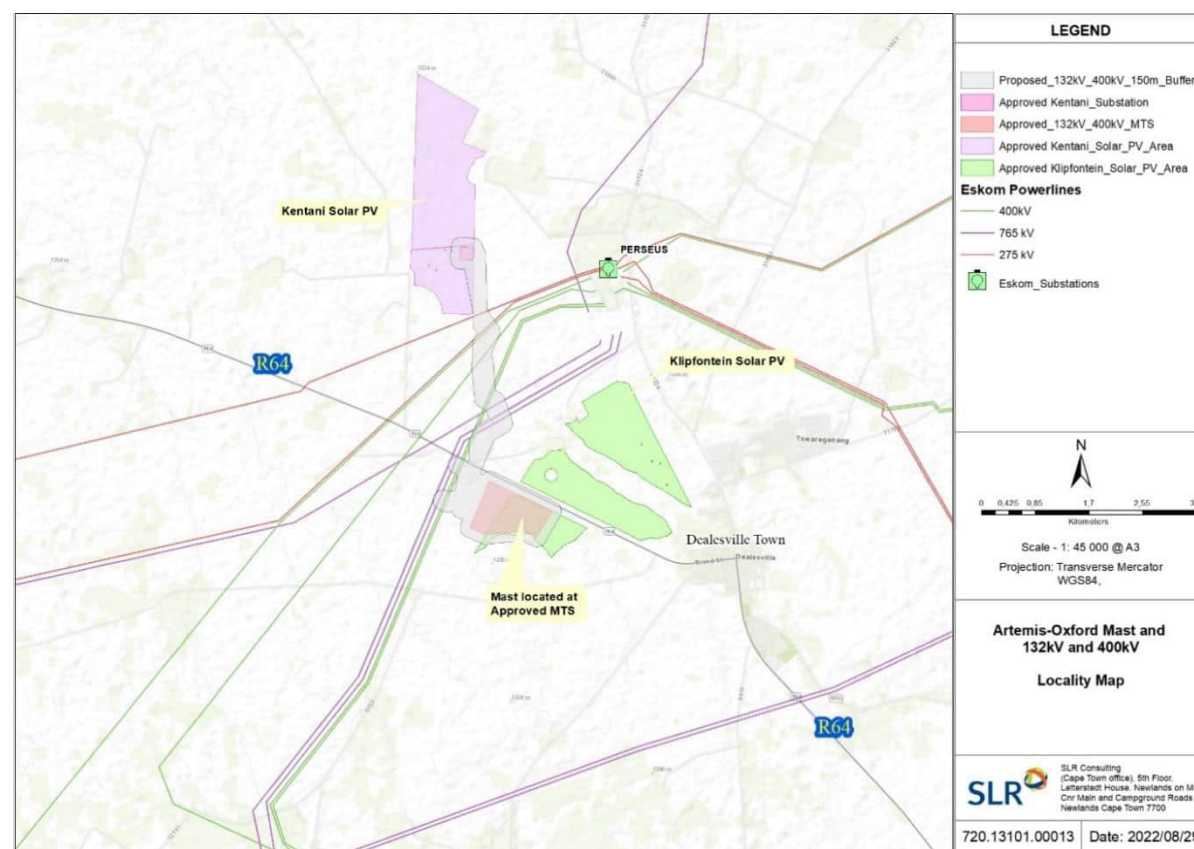

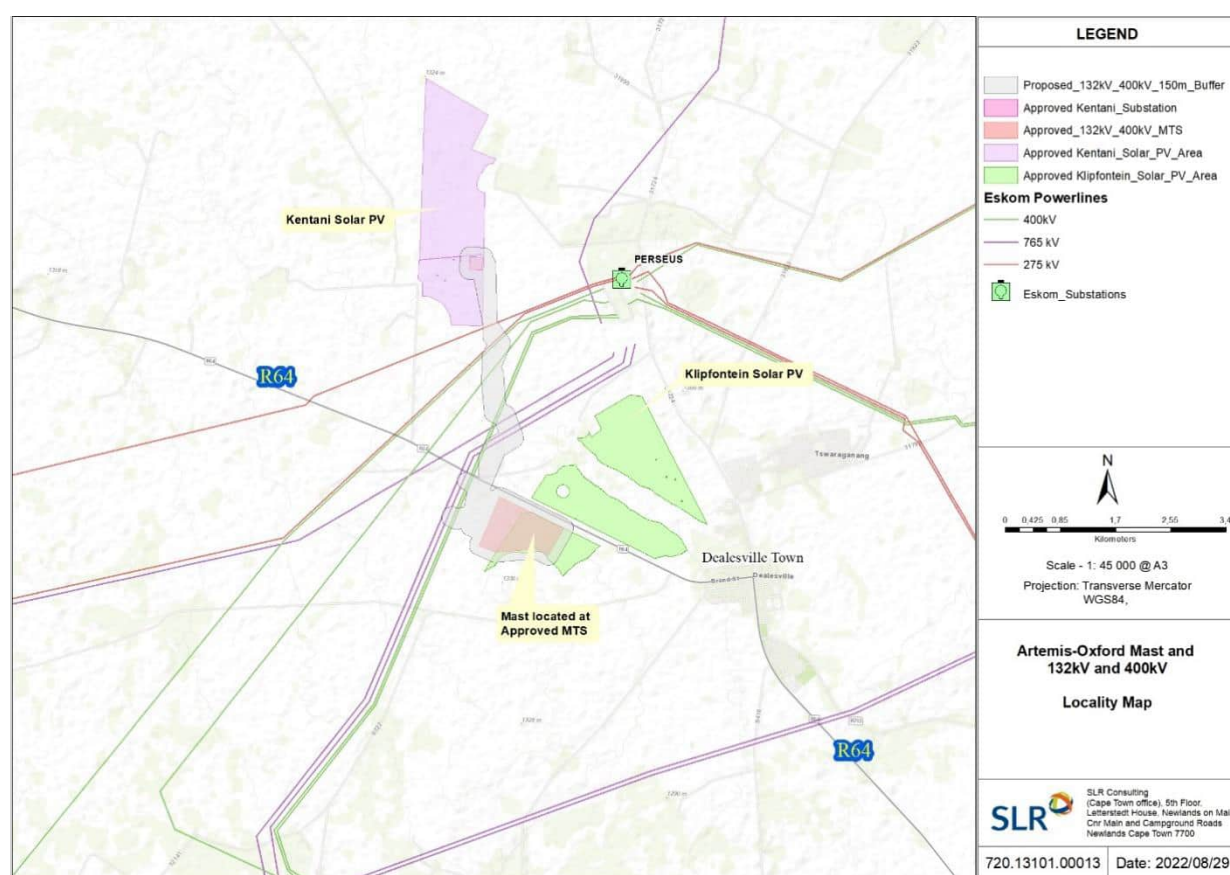


Figure 1: Radio Mast and 132kV and 400kV Infrastructure Locality

The Kentani Cluster consists of eleven (11) solar PV projects and associated electrical infrastructure (including a powerline), each of which received their own Environmental Authorisation (EA) in 2016 from the Department of Environmental Affairs (DEA) [now referred to as the Department of Forestry, Fisheries and the Environment (DFFE)]. The proposed MTS and associated infrastructure [i.e., eleven (11) powerlines] will service eleven (11) of Mainstream's solar PV projects authorised as part of the Kentani Cluster.

It should be noted that the Radio Mast will be placed within the substation footprint for the authorised 132kV/400kV MTS, while the powerlines will connect to the authorised 132kV/400kV MTS as well as to the approved 100MW Kentani Solar Photovoltaic (PV) Energy Facility (14/12/16/3/3/2/724/AM3) respectively.

In addition, a new Radio Mast is also required.

The powerlines and Radio Mast are located within the Kimberly Renewable Energy Development Zone (REDZ) (namely REDZ 4) and Central Strategic Transmission Corridor, as defined and in terms of the procedures laid out in Government Notices No. 113 and No. 145 which were formally gazetted on 16 February 2018 and 26 February 2021 respectively.

The proposed project site is located approximately 2,5km north-west of the town of Dealesville in the Free State Province. In addition, the project site is situated within the Kimberly Renewable Energy Development Zone (REDZ) as well as the Central Strategic Transmission Corridor, as defined and in terms of the procedures laid out in Government Notice No. 113 and No. 145 which were formally gazetted on 16 February 2018 and 26 February 2021 respectively.

The proposed development requires several key components to facilitate the transmission and distribution of electricity at a large scale. This includes:

1. Two (2) 400kV overhead powerlines (approx. 700m in length) are being proposed and will connect the approved MTS (14/12/16/3/3/1/2460/AM1) to the existing Eskom 400kV powerline, located west of the approved MTS site, via a Loop-In-Loop Out (LILO) connection; and
2. One (1) 132kV powerline (approx. 5km in length) is being proposed and will connect the approved MTS to the authorised Kentani on-site substation (14/12/16/3/3/2/724/AM3), located approx. 4.85km north-west of the approved MTS site.
3. One (1) 90m tapered steel lattice radio mast (also referred to as a tower) will be built within the approved MTS footprint (14/12/16/3/3/1/2460/AM1).

A road in the servitude under the proposed powerlines as well as an access road (approx. 4-8m wide) to the R64 provincial route will also be required.

As part of this new application and BA process, powerline corridors with widths of 300m (150m on either side of centre line) are being proposed and assessed for the 400kV and 132kV powerlines. 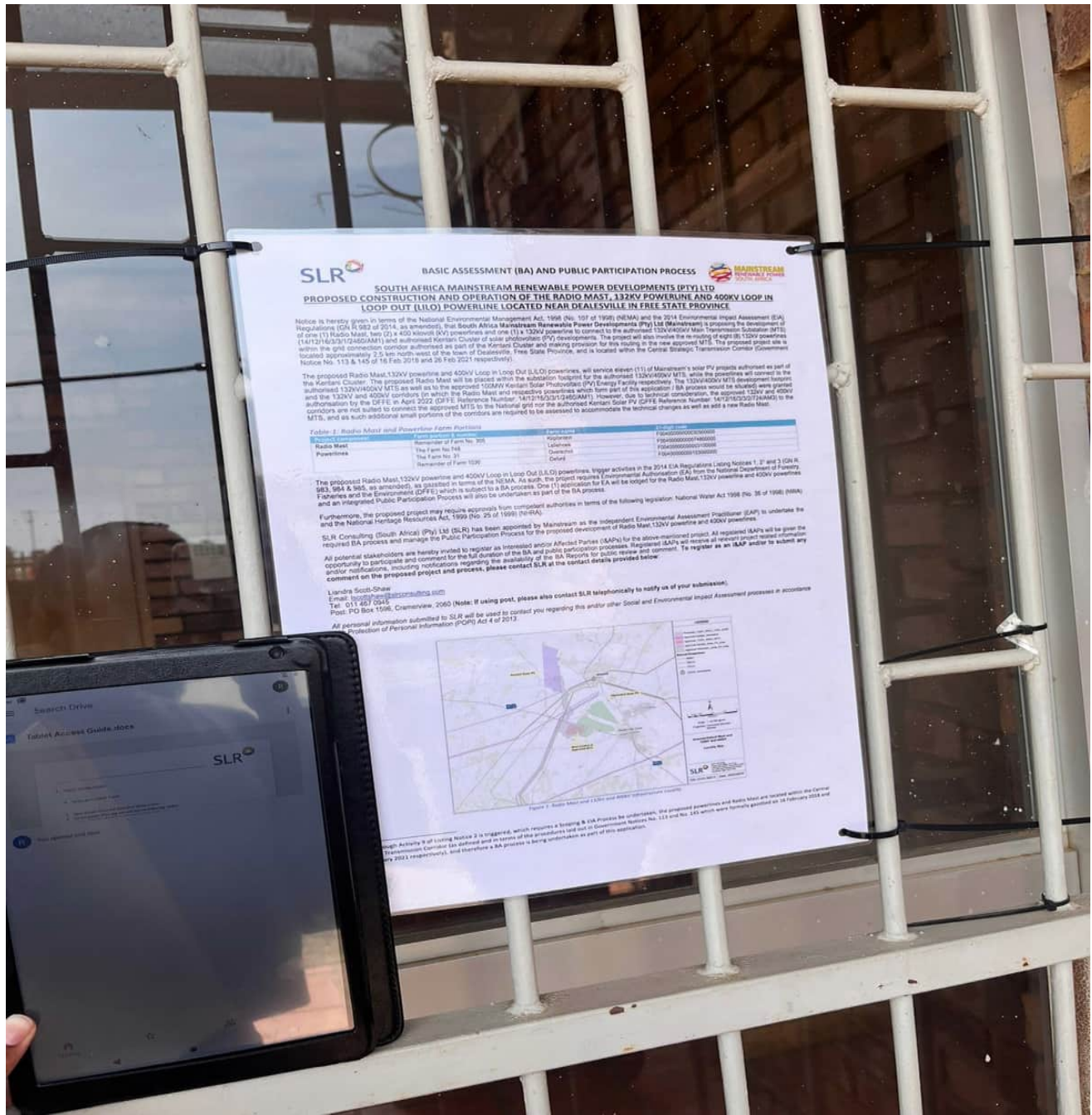

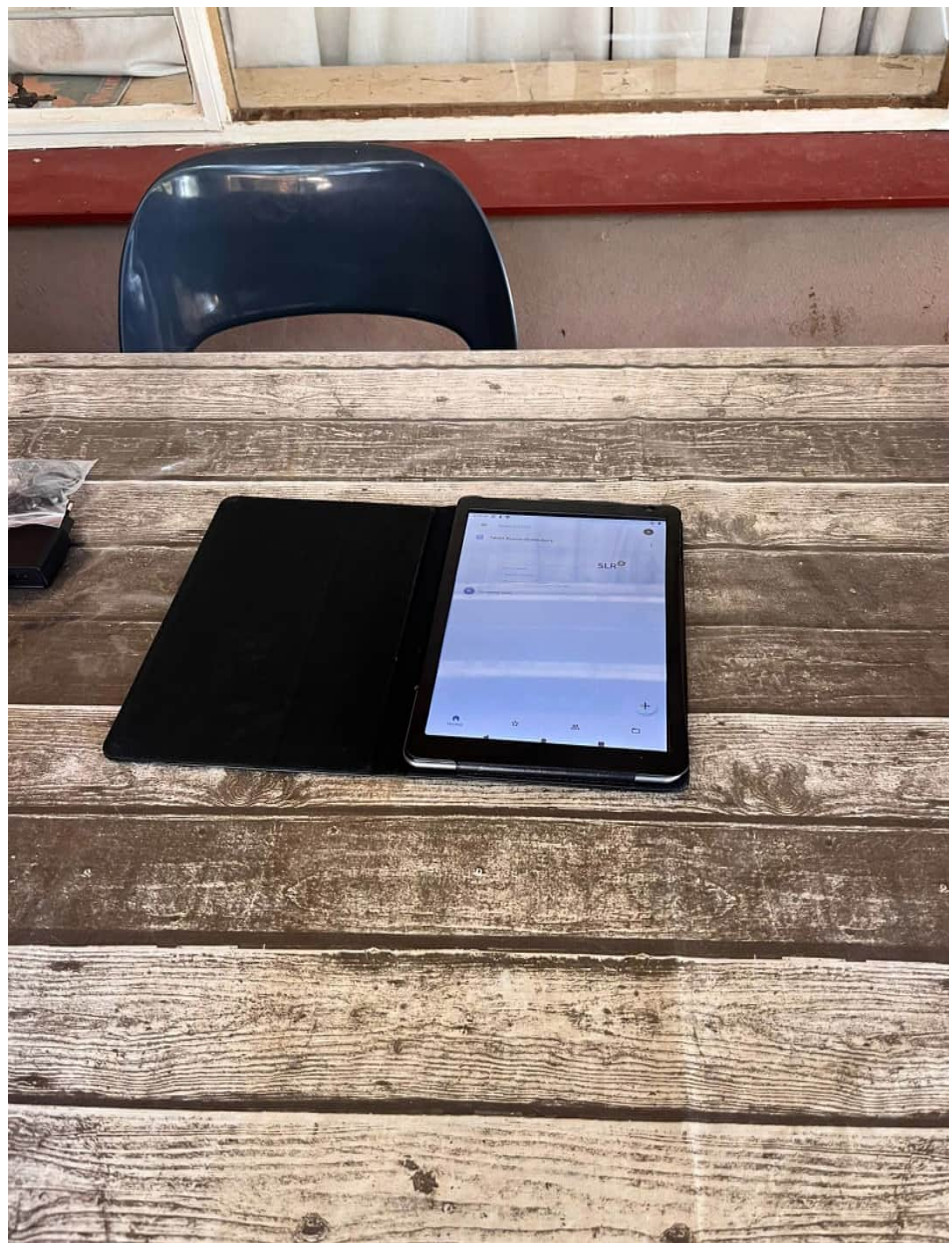
