The Basic Assessment (BA) process currently being undertaken by Savannah Environmental (Pty) Ltd for the proposed extension of the grid connection infrastructure for the Gunstfontein Wind Farm, Northern Cape Province has reference. The BA is being undertaken in terms of the National Environmental Management Act, NEMA (Act 107 of 1998, as amended) and the 2014 Environmental Impact Assessment Regulations (as amended).

An application for Environmental Authorisation was submitted to the Department on 04 September 2020 together with the draft Basic Assessment Report. The draft BAR was made available for a 30day review period from 04 September 2020 to 05 October 2020. All comments received by interested and affected parties (I&APs) during this review period have been recorded and will be included as part of the final Basic Assessment Report.

Following the submission of the application and draft BA Report to the DEFF, fine-scale walk-down surveys have been conducted by the environmental specialists and technical team allowing for more refined layout adjustments. Following the results of the walkthroughs, it was identified that minor layout updates were required for the proposed power line in order to accommodate environmental sensitivities and technical considerations. In order to ensure the updated layout has been included into the Basic Assessment report and Environmental Management Programme (EMPr), for approval together with the Environmental Authorisation (should one be issued), the draft Basic Assessment report and EMPr has been updated to reflect the revised layout. This updated draft Basic Assessment report and EMPr will also be submitted for a further 30 days public participation review period to

I&APs and Stakeholders in order to provide I&APs an opportunity to comment on the refined layout. Considering the changes to the layout and the further 30-day public review period being provided on the report, this letter serves to formally notify the Department of Environment, Forestry and Fisheries (DEFF) that the final BA Report will be submitted within 140 days of receipt of the application by the competent authority for the proposed grid extension project in accordance with Regulation 19(1)(b).

Application to be submitted

The restrictions enforced in terms of Government Gazette 43096 which placed the country in a national state of disaster limiting the movement of people to curb the spread of the COVID-19 virus has placed some limitations on the commencement and continuation of the public consultation as part of an EIA process. Considering these limitations, the following consultation process has been designed and will be implemented, on approval by the DEA, to cater for the conducting of the public participation process which includes I&APs, the competent authority, directly impacted landowners/occupiers, adjacent landowners/occupiers, relevant Organs of State departments, Municipalities, ward councillors and other key stakeholders.

Project Details:

Gunstfontein Wind Farm (Pty) Ltd proposes the construction and operation of a grid connection solution, known as the "grid extension infrastructure" for the authorised Gunstfontein Wind Farm (DEA Ref: 14/12/16/3/3/2/826), near Sutherland, Northern Cape Province. The grid connection solution will include the development of a double-circuit 132kV overhead power line (known as the Gunstfontein 132kV OHL extension double-circuit power line) to connect the Gunstfontein Wind Farm to the national grid, via the Hidden Valley substation. The proposed 132kV OHL extension will be an extension of the already authorised Gunstfontein Grid Connection (14/12/16/3/3/1/1619), which currently extends from the Gunstfontein Wind Farm to the Heuwels Substation. Other associated infrastructure will also be required for the grid connection solution, such as access tracks/roads and laydown areas. A corridor 300m wide and approximately 7.5km long along the power line with an assessment zone of 200m around the starting and terminating substation boundaries (collectively known as the grid corridor) is being assessed to allow for the optimisation of the grid (i.e. eventual micro siting) and associated infrastructure and to accommodate environmental sensitivities and other energy infrastructure currently under construction on the properties.

The 200MW Gunstfontein Wind Farm received an Environmental Authorisation in 2016, from the Department of Environmental Affairs (DEA) (DEA ref.: 14/12/16/3/3/2/826). A second Environmental Authorisation for the Gunstfontein Grid Connection (14/12/16/3/3/1/1619), including switching station, 132kV overhead powerline and ancillary infrastructure, was granted on 17 February 2017. The authorised grid connection infrastructure currently terminates at the Heuwels substation, however upon further investigation it has been identified that Heuwels substation will not have sufficient capacity to export the power from Gunstfontein Wind Farm. It is therefore necessary to by-pass Heuwels substation and extend the authorised grid connection to connect to the Hidden Valley substation located ~7.5km south of the Heuwels substation. This application therefore focusses on the extension of the already authorised 132kV power line, required by Gunstfontein Wind Farm to evacuate the generated power to the national grid, at the identified grid connection point, i.e. the Hidden Valley Substation.

The full length of the assessed 300m wide corridor and 200m around each substation traverses four (4) affected properties, namely:

- » RE Portion 1 of the Farm Orange Fontein No. 203;
- » RE of the Farm Annex Orange Fontein No. 185;
- » RE of the Farm Leeuwe Hoek No. 183; and
- » The Farm De Hoop No. 202.

The following activities will be triggered by the proposed development, requiring a Basic Assessment process for environmental authorisation:

Listing Notice 1 (GNR 327 of 7 April 2017):

- » 11(i): infrastructure for the transmission and distribution of electricity outside urban areas with a capacity of more than 33 but less than 275 kilovolts.
- » 12 (ii): The development of infrastructure within 32 metres of a watercourse, measured from the edge of a watercourse
- » 14: the storage and handling, of a dangerous good exceeding 80 cubic meters or more but not exceeding 500 cubic meters.
- » 19 (i): infilling or depositing of any material of more than 10 cubic metres into a watercourse
- » 24 (ii): development of a road with a reserve wider than 13,5 meters, or where no reserve exists where the road is wider than 8 metres
- » 27 (i): clearance of an area of 1 hectares or more of indigenous vegetation
- » 28 (ii): Commercial developments of more than 1ha where such land was used for agriculture on or after 01 April 1998

<u>Listing Notice 3 (GNR 324 of 7 April 2017):</u>

- » 4(a)(ii)(bb): The development of a road wider than 4 meters with a reserve less than 13,5 meters within a critical biodiversity area.
- » 10(g)(ii)(iii)(ee): storage and handling of a dangerous good, where such storage occurs in containers with a combined capacity of 30 but not exceeding 80 cubic meters within critical biodiversity areas or within 100m from a watercourse.
- » 12(d)(ii): The clearance of an area of 300 square meters or more of indigenous vegetation within a critical biodiversity area.
- » 14 (ii)(c)(g)(ii)(bb&ff): The development of (iii) infrastructure or structures with a physical footprint of 10 square meters or more within 32m of a watercourse and within a critical biodiversity area.
- » 18(g)(ii)(bb & ee): The widening of a road by more than 4 metres; or the lengthening of a road by more than 1 kilometre within critical biodiversity areas.

Public Participation Plan:

The public participation (PP) process will be undertaken in accordance with the requirements of Regulations 39 to 44 of the Environmental Impact Assessment (EIA) Regulations, 2014, as amended, (GNR 326). The aim of the public participation process is primarily to ensure that:

- » information containing all relevant facts in respect of the proposed project is made available to potential stakeholders and I&APs;
- » participation by I&APs is facilitated in such a manner that all potential stakeholders and I&APs are provided with a reasonable opportunity to comment on the proposed project; and
- » comments received from potential stakeholders and I&APs are recorded and incorporated into the EIA process.

Alternative means of undertaking consultation has been designed and will be implemented by Savannah Environmental to ensure that I&APs are afforded sufficient opportunity to raise comments on the project through an interactive web-based platform readily available and accessible to any person illustrating interest in the project and enables the public participation process to be undertaken in line with Regulations 41 to 44 of the EIA Regulations, 2014, as amended. This online stakeholder engagement platform allows the EAP to visually present details regarding the project and our consultation documentation, including project maps and plans, presentations and posters regarding the project, and reports available for review. The use of online tools enables stakeholders and I&APs to explore the project-specific content in their own time, and allow them to participate in a meaningful way in the consultation process. The online platform allows for instant feedback and comments to be submitted, in so doing saving time for the stakeholder and also giving the

assurance that their comments have been submitted for inclusion in the project reporting.
