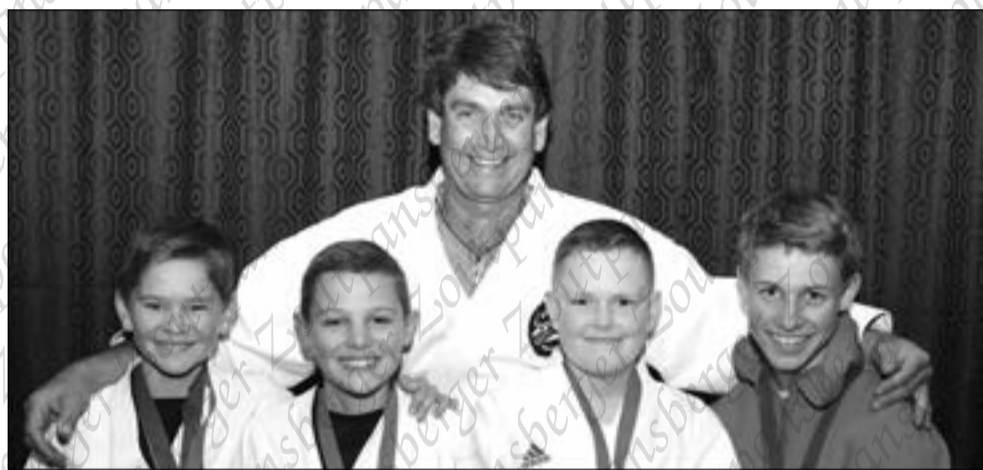

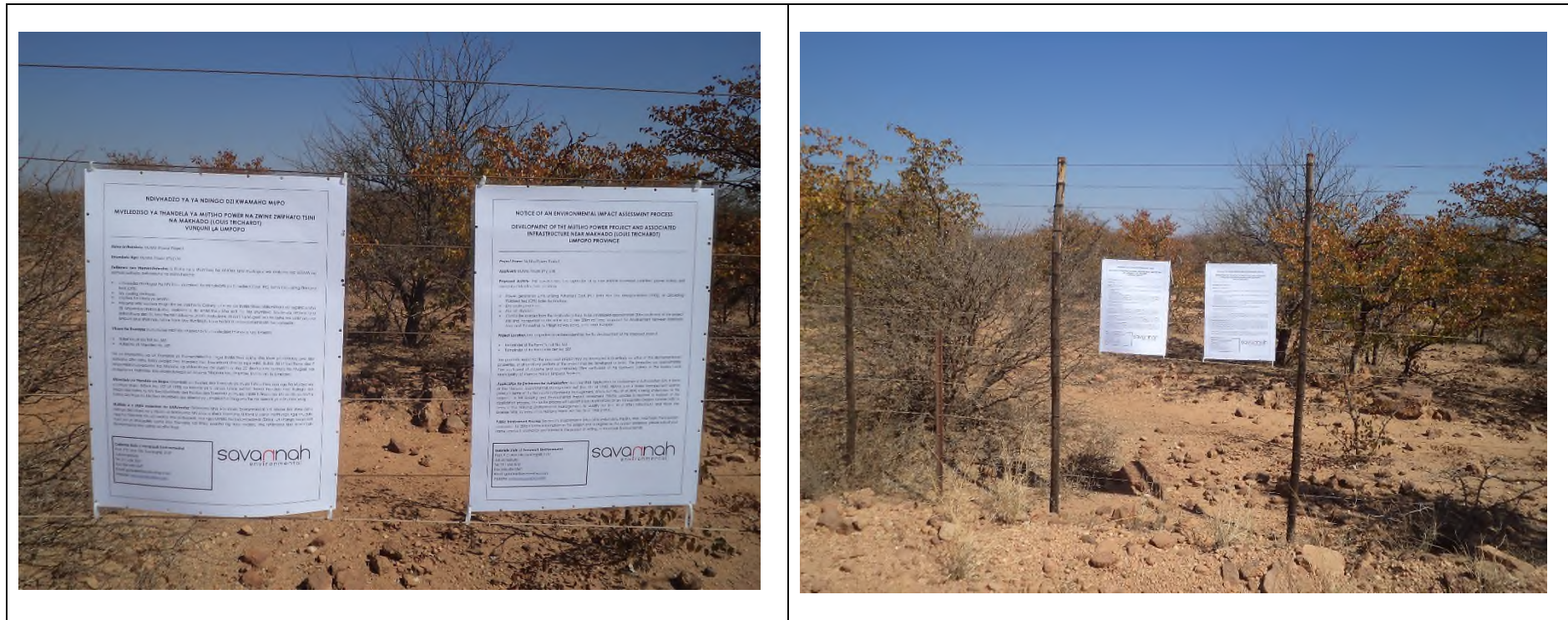






Figure 2: Site notice placed on the farm boundary of the Farm Vrienden 589 (22° 41' 17" S; 29° 48' 24.5" E).

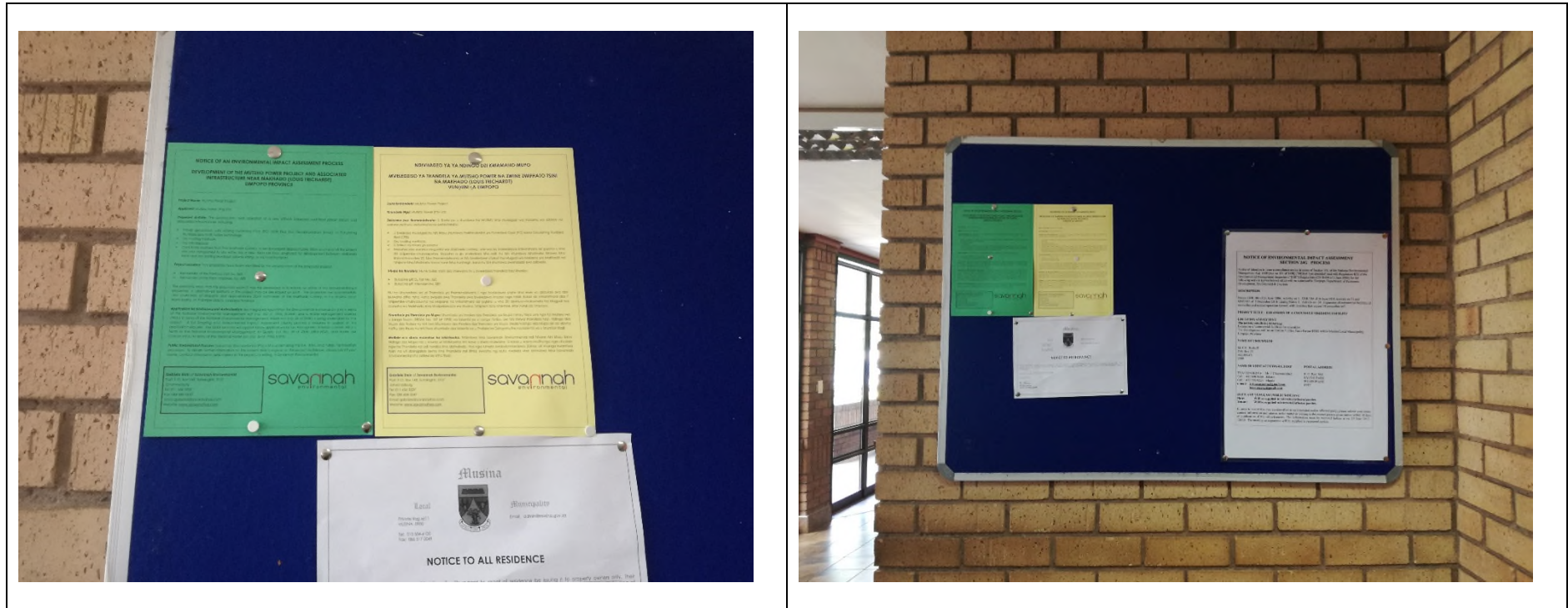


Figure 3: Notices placed on the notice board of the Musina Local Municipality.
