DA leads fight against crime in Kuruman

The Democratic Alliance (DA) in the Northern Cape has made headway in its fight against crime in the Kuruman area, which was recently put under the spotlight following the mugging of Mr Giep Niemann, in the central business district of Kuruman last week.

According to Willie Aucamp, DA Member of Parliament and DA Constituency Head of Kalahari, successful meetings between himself, DA councillor Braam van der Westhuisen and safety stakeholders, including the JTG Cluster Commander Major General Johan Bean and Colonel Ben Phete from the SAPS Kuruman, as well as the Chairperson of the Neighbourhood Watch, Paul Marais, all agreed on practical measures that will immediately improve accessibility to law enforcement and ultimately, also policing.

In this regard, it was decided that the SAPS function of certifying documents and the taking down of affidavits, which generally result in very long, slow moving queues at the SAPS Kuruman police station, would be shifted to an alternative building. This will make police services more accessible, and better encourage victims to report crime. This is of critical importance, because if crime is not reported, statistics are skewed. This in turn affects the allocation of resources to police stations.

In addition, the DA has committed to assist with the recruitment of community members to sign up as police reservists. This is also important because, for every extra police reservist who can assist with tasks, such as the answering of phones, there can be an additional police officer out on the street to combat crime and apprehend criminals.

The DA also pledged to continuously put pressure on the national Police Minister, Bheki Cele, to ensure that vacant posts are filled as a matter of urgency, and that the dire shortage of operational police vehicles in Kuruman, and in the province, receive attention.

Mr Aucamp said that he would expose these challenges by asking parliamentary questions and utilising other parliamentary channels to lobby for change in respect of policing.

In the meantime, the DA is also looking at further improving cooperation amongst all sectors in the joint fight against crime. On this note, General

Bean also agreed to arrange a meeting with the DA, the SAPS and all security firms in Kuruman.

Due to the lack of enforcement of by-laws by the Ga-Segonyana municipality, which in turn places an extra burden on the SAPS, Mr Aucamp and Councillor Van der Westhuisen, together with General Bean, a meeting with municipal management to see how this issue can be addressed, is being scheduled.

The DA appreciates the willingness of the SAPS Kuruman to join hands with the community and the neighbourhood watch groups, to collectively tackle crime. Crime is everyone's problem and only by uniting forces can safer communities be built.

Kathu suspect arrested for murder of Pofadder hotel owner

A joint investigative team comprising of the SAPS Provincial Organised Crime unit, the DPCI and Pofadder and Springbok detectives, led by Brigadier Dick de Waal, arrested two suspects in connection with the murder of Pofadder hotel owner Leon Brits.

This is according to Brigadier Mohale Ramatseba from the Office of the SAPS Provincial Commissioner in Kimberley.

The deceased was stabbed to death on 07 October 2020 in Pofadder.

The one suspect aged 37, was arrested at Piketberg in the Western Cape, while the other suspect, aged 34, was arrested at Kathu in the John Taolo Gaetsewe district.

The acting Provincial Commissioner Major General Phiwe Mnguni, applauded the investigating team which led to the arrest of the suspects.

The suspects appeared at the local Magistrates Court in Pofadder on Monday 19 October 2020 and the case was postponed to 26 October 2020.

The police investigations continue.

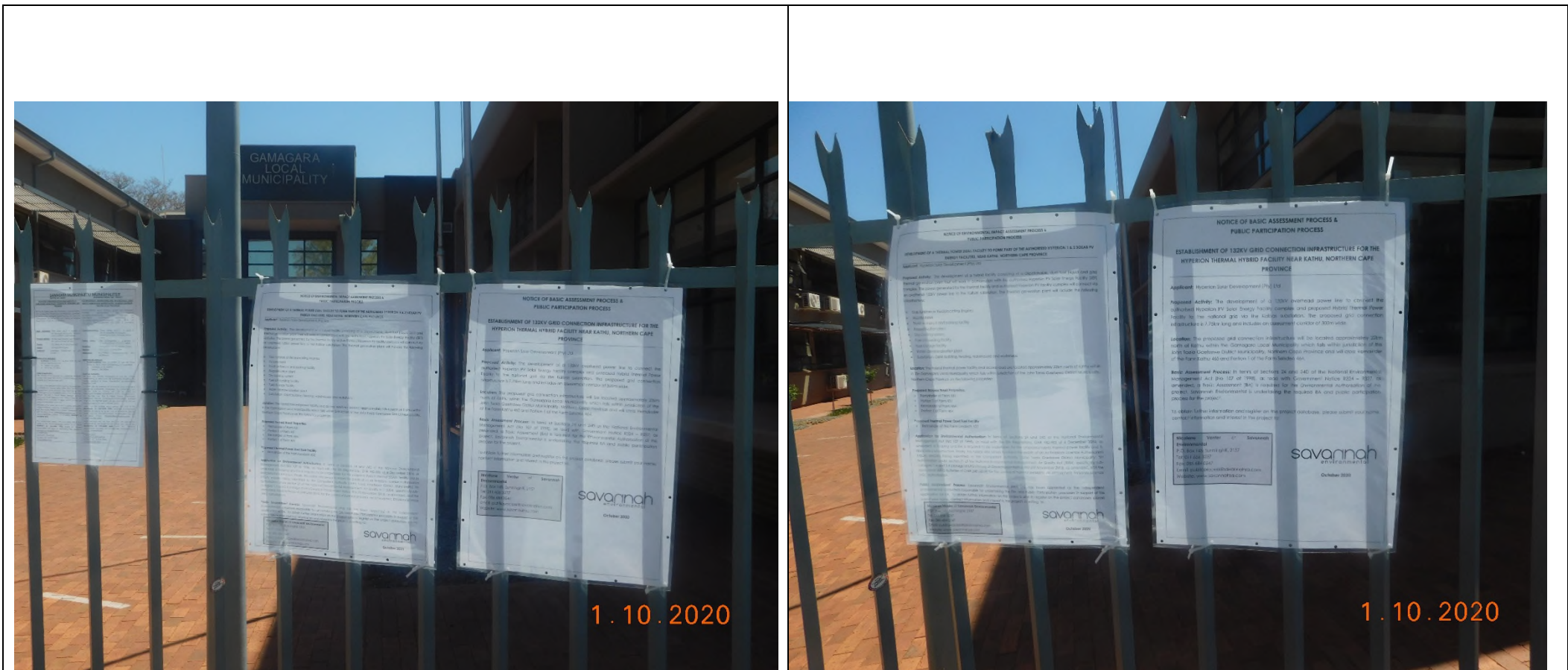
