

ENVIRONMENTAL ASSESSMENT OF THE PROPOSED, COMBINED MINING OPERATIONS: PILANESBERG PLATINUM MINES' TUSCHENKOMST PIT EXTENSION; SEDIBELO PLATINUM MINE'S INFRASTRUCTURE AMENDMENT; AND THE MAGAZYNSKRAAL PLATINUM MINE

Notice is given in terms of the Mineral and Petroleum Resources Development Act, 28 of 2002 of the intent to carry out mining operations at each of the above-mentioned project sites. In addition the National Environmental Management Act, 107 of 1998 (NEMA), and the National Environmental Management: Waste Act, 59 of 2008 (NEMWA) are applicable as these projects will also entail activities in terms of NEMA and NEMWA. Given the nature of the projects, an environmental impact assessment (EIA) will be required, that will include both scoping and EIA procedures. Furthermore, each of these projects will require authorisation in terms of the National Water Act, 36 of 1998. The three project sites are located adjacent to one another, and will operate as a combined mining operation.
