The study area is extensively disturbed by agricultural activities. No archaeological and historical resources or graves were found in the proposed development area. Several known graves occur in the area, which lie outside the development footprint area.

As the vegetation cover resulted in poor visibility in the area, graves may be expected in the area and the author recommends that a chance find procedure be in place and incoprorated in the EMP for this project.

Final comment

Based on the lack of archaeological and palaeontological heritage resources in the proposed area, the SAHRA APM Unit has no objection to the proposed construction of the solar facility within the Lethabo coal fired power station boundary. The following conditions, as recommended in the HIA, PIA and incorporated in the EMPR, must be adhered to:

- 1. Should any objects of archaeological or palaeontological remains be found during construction activities, work must immediately stop in that area and the Environmental Control Officer (ECO) must be informed.
- 2. The ECO must inform the South African Heritage Recourse Agency (SAHRA) and contact an archaeologist and/or palaeontologist, depending on the nature of the find, to assess the importance and rescue them if necessary (with the relevant SAHRA permit). No work may be resumed in this area without the permission from the ECO and SAHRA.
- 3. If the newly discovered heritage resource is considered significant a Phase 2 assessment may be required. A permit from the responsible heritage authority will be needed.
