# REPORT ON THE RESULTS OF CONSULTATION

# WITH COMMUNITIES AND INTERESTED AND AFFECTED PARTIES

AS REQUIRED IN TERMS OF SECTIONS, 16(4)(b) OR 27(5)(b) OF THE MINERAL AND PETROLEUM RESOURCES DEVELOPMENT ACT (ACT 28 OF 2002), AND IN ACCORDANCE WITH THE STANDARD DIRECTIVE FOR THE COMPILATION THEREOF AS PUBLISHED ON THE OFFICIAL WEBSITE OF THE DEPARTMENT OF MINERAL RESOURCES

#### A. Definitions

'consultation' means a two way communication process between the applicant and the community or interested and affected party wherein the former is seeking, listening to, and considering the latter's response, which allows openness in the decision making process.

'community' means a group of historically disadvantaged persons with interest or rights in a particular area of land on which the members have or exercise communal rights in terms of an agreement, custom or law: Provided that, where as a consequence of the provisions of the Act negotiations or consultations with the community, directly affected by prospecting or mining, on load occupied by such members or part of the community:

### B. Report on the results of consultation

Various farms were identified for the proposed prospecting activities by De Groote Boom Minerals (Pty) Ltd (De Groote Boom), to compile and submit an Environmental Management Plan (EMP), pursuant to an application for a mining permit, in terms of the Mineral and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002) (MPRDA) to the Limpopo Department of Mineral Resources (DMR). The Project is situated on the Farm De Grooteboom 373 KT, near the town Steelpoort, situated in the Limpopo Province.

The Mining Permit Application (MPA) has been accepted by the Regional Manager, Limpopo Region, of the DMR under Reference LP 10656 MR and De Groote Boom has been instructed to prepare an EMP, which will include various specialist investigations, and a Public Participation Process (PPP) will be undertaken. Below in *Table 1* are the farms included as part of the Mining Permit Application.

#### 1. Methodology applied to consultation

**1.1** Name the community or communities identified, or explain why no such community was identified.

Within the applicable MPA area no communities were identified, hence, no communities are landowners or occupiers within the MPA area. However, the following communities were identified who reside within the indirect study area (in the excess of 3 km):

- Buffelshoek Community;
- Kalkfontein Community;
- Richmond Community; and
- Moletsi Dwars River Community.
- **1.2** Specifically state whether or not the Community is also the landowner.

No communities are landowners within the MPA area. Directly affected landowners were identified by means of Windeed searches, utilising information from an existing stakeholder database and telephonic consultations undertaken with landowners. A field visit was conducted by the Heritage Specialist in April 2015 in order to identify affected communities together with traditional authorities. Landownership of the relevant farms is provided in *Table 1*.

**1.4** State specifically whether or not a land claim is involved

A request for land claims information was submitted to the Limpopo Department of Rural and Land Reform to Mrs Gladys Kekana, Email: <a href="mailto:ngkekana@ruraldevelopment.gov.za">ngkekana@ruraldevelopment.gov.za</a>, Tel (015) 284 6324 of which the outcome of any land claims over the applicable Farms are detailed below.

A directive from the DMR stated that consultation needs to be undertaken with the Department of Land Affairs, if the affected land is state-owned, or the office of Commission of Land Rights, if the affected land is subject to land restitution. A summary of the outcome is provided within this section and the full report can be referred to in *Appendix G*.

Through the process to establish landownership it was found that no properties are owned by the Department of Land Affairs. As such, consultation was undertaken with the office of the Commission of Land Rights in order to determine if the affected properties are subject to land restitution.

The Digby Wells Stakeholder Engagement office engaged, by means of telephone and email, with representatives from the Department of Rural Development and Land Reform as stipulated below on Wednesday, 18 March 2015 and Tuesday, 24 March 2015:

The purpose of these engagements was to firstly ensure that the relevant representatives from the Department Rural Development and Land Reform are consulted and secondly to determine if the affected properties are subject to land restitution. A formal enquiry for directly affected and adjacent properties was submitted on Wednesday, 18 March 2015.

Feedback was received from the Office of the Regional Land Claims Commissioner: Limpopo on Monday, 23 March 2015 (refer to *Appendix G*) which indicates the following:

- Farms De Grooteboom 373, Dwars Rivier 372, Frischgewaagd 359, Tweefontein 360 and Thorncliff are subject to restitution land claims by the Masha Community and Moletsi Dwars Rivier Community; and
- Farms Zwakwater 377 and Rieftontein 375 indicated that no information relating to restitution land claims existed.

The Department Rural Development and Land Reform indicated that research about the restitution land claims is ongoing and that relevant correspondence would be provided should claims be identified that satisfy requirements of the Restitution of Land Rights Act (Act no 22 of 1994).

The proposed mining operations will be conducted using invasive and non-invasive methods. Because of the open cast mining, invasive methods will result in land disturbances. However, the socio-economic conditions of land occupants will not be directly impacted since site rehabilitation will be undertaken and mitigation measures implemented throughout the mining process. Specialist studies are being undertaken in order to understand impacts incurred by the proposed project. As part of the studies a social specialist study impact assessment will be completed which will provide more comprehensive information regarding the impact on socio-economic conditions of landowners. This information will be included as part of the Environmental Management Plan (EMP) where mitigation measures will be prescribed in order to minimise social impacts as far as possible.

#### **Identification of Stakeholders**

To ensure a proper representation of stakeholders interested in or affected by the proposed, the following identification methods were used to develop a stakeholder database:

- Utilisation of an existing stakeholder database;
- Conducting Windeed and related desktop searches in and around the project to verify landownership and obtain contact details;
- Responses to be received from newspaper advertisements and site notices;
- Responses on the distribution of the Background Information Document (BID); and
- Telephonic and one-on-one consultations with stakeholders to identify additional I&APs.

Stakeholders for the proposed project are grouped into the following categories:

- Government: National, Provincial, District and Local authorities;
- Landowners: Directly affected and adjacent landowners;
- Land occupiers: Directly affected and adjacent land occupiers;
- Communities: Surrounding communities;

- Background Information Document (BID): includes the location and a description of
  the proposed project, the legislative processes and requirements that will be followed,
  the specialist studies to be conducted, the competent authorities, and the consultation
  and registration process including contact details of the responsible person representing
  the EAP.
- **Newspaper Advertisement:** an English newspaper advert was placed in one local newspaper. The advert included a brief project description, information about the required legislation, the competent authorities and details of the appointed EAP.
- **Site Notices:** English site notices were put up at various places as indicated in *Table 2*. The site notices contained a brief project description, information about the required legislation, the competent authorities and details of the EAP.
- Letter with Registration and Comment Sheet: a letter was sent in English which contained information about the proposed project, applicable legislation and competent authorities. A Registration and Comment Sheet was also provided for stakeholders to use for formal registration as I&APs or to submit comments.

#### **Consultation with Stakeholders**

**Telephonic consultations**: various telephonic consultations were conducted with directly affected landowners, adjacent landowners, traditional authorities and communities during April 2015.

**Written comments:** All comments received via email, mail or telephonically have been included into the Comment and Response Report (CRR) (see *Appendix H*). Stakeholder comments will be closely considered and addressed, where applicable, by the project team. Responses are provided to the comments raised by stakeholders and included in the CRR.

- 2. Description of the existing status of the cultural, socio-economic or biophysical environment, as the case may be, prior to the proposed prospecting or mining operation.
- **2.1** Confirm that the identified and consulted interested and affected parties agree on the description of the existing status of the environment.

Stakeholders made no comment as to the status of the existing environment. All other comments received have been captured in the Comment and Response Report (CRR) (see *Appendix H*).

**2.2** Describe the existing status of the cultural environment that may be affected

The dominant ethnicity of the area is Pedi. An influx of job seekers could introduce more diverse cultures although residents have stated that previous mining developments haven't really attracted too many foreigners. No current sites of cultural significance such as initiation sites or other culturally significant sites were identified.

2.3 Describe the existing status of any heritage environment that may be affected

A total of 6 heritage resources were identified within the De Grooteboom study area. These included two Stone Age sites, three Iron Age sites and one possible gong rock. The heritage resources were of negligible significance and value and therefore the impact on these heritage resources was negligible. The HIA did not assess intangible or living heritage that may be

associated with the study area and identified sites, as time and budgetary constraints did not allow for this. However, it is acknowledged that various elements of living heritage may be associated, for example by land claimants, among other communities.

Based on the Heritage Scoping Report and the Heritage Impact Assessment, Digby Wells recommends the following:

- A Watching Brief should be conducted during the construction of the roads and infrastructure areas. The Watching Brief will entail a qualified archaeologist to be present on site during site clearance to identify and investigate possible heritage resources that may be uncovered during construction;
- It is recommended that CFPs be developed and included within the EMP for the mining area and the general DGP area. The CFPs must clearly define the reporting structure and action items required in the discovery or accidental exposure of possible heritage resources during construction and operational activities;
- Additionally, should the mining operation prove to be successful and a Mining Right be applied for, Environmental Authorisation will be applied for which must include a full HRM process, inclusive of a Heritage Impact Assessment (HIA) which should consist of the following:
  - Archaeological Impact Assessment (AIA); and
  - Stakeholder consultation to identify potential ancestral sites and/or burial grounds.
- **2.4** Describe the existing status of any current land uses and the socio-economic environment that may be directly affected

De Grooteboom Farm used to be a game ranch but game has moved on since the arrival of mining in the area. The land is used to lodge contractors who are working at surrounding mines some of them are staying here for extended periods of time. There is also a lodge operational with a bar and restaurant. This lodge currently relies on business provided by mine contractors in the area. There is also a compound where employees of the lodge stay. There is no agriculture present on the land although the land owner allows some employees and other herdsman in the area to graze their cattle on the land. An increase in mining activity will likely increase the business of the lodge.

**2.5** Describe the existing status of any infrastructure that may be affected.

Current infrastructure found in the area is only the lodge, homes of the landowners, homes of the employees of the lodge, gravel and dirt roads and a power line that provides these homes with electricity. Additional road access could be another positive. Residents are concerned about an increase in traffic as mining in the area has increased carrying capacity of roads in the area. They are also worried about nuisances such as noise, dust, potential water contamination and visual impact to their surroundings affecting sense of place.

**2.6** Describe the existing status of the biophysical environment that will be affected, including the main aspects such as water resources, flora, fauna, air, soil, topography etc.

#### Soil

The study area is dominated by shallow rocky soils (Mispah/Glenrosa) on upper slopes. The flatter slopes show greater accumulation of soil. The dominant soil in the downslope region is Hutton soil form. The lower slopes are currently used for subsistence grazing. There is evidence of overgrazing and large areas of erosion. This is due to the combination of high runoff velocity from the steep slopes and reduced ground cover (overgrazing).

The dominant land capability for the area is the Class VI (Moderate Grazing) and Class VIII (Wilderness). These capability classifications are due to the steep slopes. The footslopes where the slopes are less than 5% the shallower soils (Mispah/Glenrosa) have a Class IV (Low Cultivation/Intensive Grazing) land capability. The deeper Hutton soils have Class III (Moderate Cultivation) land capability. The land use dominating the study area is natural veld which has been used in some parts for subsistence grazing by the community. There are portions downslope that show signs of erosion.

#### Water resources

The De Groote Boom study area is located within the Olifants Water Management Area (WMA 4) and within quaternary catchments B41G and B41H, with majority of the study area falling within quaternary catchment B41G. A number of non-perennial streams drain the mountain where the infrastructure and open cut mining is planned and may potentially be impacted as a result of the project. These non-perennial streams were found to be seasonal and only likely to flow after rainfall. The southernmost branch of non-perennial streams drains the proposed mining area into the Springkaanspruit, which was found to be flowing at the time of the site visit. The non-perennial streams to the west and north of the mining area drain into the Dwars River, after the confluence of the Groot Dwars and Klein Dwars Rivers. Water quality sampling conducted in April 2015 near the study area indicated that water quality within the Groot Dwars and Dwars Rivers was good, with all analysed parameters within the SANS 242-1:2011 drinking water quality standards.

#### Fauna and Flora

The study area is located within the Sekhukhuneland Centre of Plant Endemism (SCPE) and 58 endemic plant species are known to occur in the area. Endemic fauna are also present in the SCPE, and the Sekhukhuneland Flat Lizard (*Platysaurus orientalis*) and the Cicada (*Pycna sylvia*) are likely to occur on site. The site is also situated in a Nationally Threatened Ecosystem, namely Sekhukhune Mountainlands.

**3.1.5** Provide a list and description of potential impacts identified on the biophysical environment including but not limited to impacts on: flora, fauna, water resources, air, noise, soil etc.

#### Soil

#### Construction Phase

During the construction phase the work carried out will include the construction of the mine and supporting infrastructure. This will entail the clearing of areas and the disturbance of the topsoil through excavations as well as the construction of a soil stockpile. The topography and natural drainage lines will be disturbed. The overall impact will be loss of topsoil as a result of erosion and possible contamination of the soil by fuel, and oils due to the excavation activities. Soil compaction caused by heavy vehicles and machinery surrounding the open cut areas could also be a problem.

Soil stripping will require the removal of all soil materials to a depth of at least 0.3 m. This activity will provide needed soil cover material for rehabilitation purposes. Construction activities will change the land use from natural/subsistence grazing to mining causing unsuitable conditions for any further commercial farming.

#### Operation Phase

Soil erosion through wind and storm water run-off, and soil pollution by means of hydrocarbon contamination and, may be encountered during the operational phase. Water runoff from roads must be controlled and managed by means of proper storm water management facilities in order to prevent soil erosion. Diesel and oil spills are common at mine sites due to the large volumes of diesel and oil consumed by mining vehicles, also vehicles must be maintained to reduce the chances of any leaks occurring. Pollution may however be localised. Small pockets

of localised pollution may be cleared up easily using commercially available hydrocarbon emergency clean-up kits.

#### Decommissioning Phase

During the decommissioning phase all infrastructure will be demolished and removed, which will entail vehicle movement in the infrastructure area. The potential impacts associated with these activities will include the risk of hydrocarbon spills, and compaction. The rehabilitation of the mining area and infrastructure area should have a positive impact if done correctly.

#### Water resources

The following are identified as significant water impacts:

- Removal of vegetation and topsoil exposes the soil, leaving it prone to soil erosion which may cause siltation of water resources.
- Storage of diesel and other hazardous substances onsite has the potential to spill and contaminate water resources.
- Water management: channels, pipelines and PCD should be appropriately sized and maintained to avoid spills that may wash into water resources.
- Haul roads used by heavy machinery has the potential to deteriorate causing erosion and subsequent siltation of water resources. Storm water structures need to be implemented and roads regularly maintained.
- Rehabilitation of the site is extremely important, and should rehabilitation not take place, then long term impacts on surface water resources may be the result.

#### Fauna and Flora / Ecology

The following impacts from the proposed project on ecology have been identified:

- Removal of vegetation;
- Disturbance of the soil;
- Vehicle operation;
- Establishment of alien plant species in disturbed areas;
- Increased human presence; and
- Machinery and vehicle operation (noise).

An initial field survey was undertaken in September 2014, and in March 2015. The plant species list amounted to 62 species although many more may occur. The natural vegetation was found to be largely intact and only a single alien plant was recorded for the site. Nine plant Species of Special Concern (SSC) were expected to occur on site, four of which were confirmed during the field survey. A total of 6 mammals were confirmed to occur within the study area during the field survey, The Brown Hyaena (Hyaena brunnea) and African Leopard (Panthera pardus) were reported to be present on site by the farmer at De Grooteboom. These species will relocate during any major disturbance, but are regarded as Vulnerable according to the IUCN.

The impact of the proposed mine is regarded as highly significant. Although limited in extent, the regional and local sensitivity of the study area deems it as very important for biodiversity

and natural heritage. Plant endemism and diversity, as well as the fact that the SCPE has not been fully described taxonomically, are factors that contribute to the sensitivity of the site.

**3.1.6** Provide a description of potential cumulative impacts that the proposed operation may contribute to considering other identified land uses which may have potential environmental linkages to the land concerned.

- 4. Land use or development alternatives, alternative means of carrying out the proposed operation, and the consequences of not proceeding with the proposed operation.
- **4.1** Provide a list of and describe any alternative land uses that exist on the property or on adjacent or non-adjacent properties that may be affected by the proposed mining operation.

Most of the Farm is used for recreational purposes and of course the lodge. There is a tarred road that runs between the R55 and Lydenburg (R577), this road appears to be busy with a lot of trucks hauling goods along it. There is evidence of erosion being a problem in the area as we noticed some large gullies. Generally the study area and surrounding area is sparsely populated with one or two households scattered around the area, the closest densely populated area is a township called Kalkfontein which is approximately 8 km to the west of the study area. Didingwe River Lodge is situated 1 km south of the project boundary and it is anticipated that this lodge would not be affected too much. To the west of the project boundary a fair amount of mining activity is taking place and some activity to the south and north.

No land developments were identified by the community during the consultation undertaken for the prospecting rights application.

No suggestions were made by stakeholders through the consultation process relating to operational plans.

**4.4** Provide information in relation to the consequences of not proceeding with the proposed operation.

The demand for PGMs was boosted in the first nine months of 2010 by improved economic conditions, which lifted business and consumer confidence and led to a recovery of many industrial sectors. Gross industrial demand for platinum was forecasted to increase in 2010 as better economic conditions drive restocking and production levels across many industrial sectors. In addition to the local and national economic benefits of the proposed mining operation, there will also be a social benefit.

Direct economic benefits will be derived from wages, taxes and profits and local and regional employment opportunities would be created. Indirect economic benefits will also be derived from the procurement of goods and services and the increased spending power of employees. Increased business opportunities for local entrepreneurs through the supply of goods and services to the mine will also be evident.

The De Groote Boom project would contribute towards economic development through employment opportunities, improvement of procurement of services and increase in social development projects for the communities in the local area. The aforementioned benefits would be omitted should the proposed project be deemed unviable to proceed with development.







Plan 1: Regional Setting





# Formal burial of MK veteran brings closure

PENGE - On Saturday the Tubatse community buried one of their beloved sons, Mr Meshack Komsasa Nyathi, after his remains were exhumed from the Tshikota Cemetery by the Missing Persons Task Team. The service was held at Leagathoko High School and his remains reburied at Penge Cemetery.

Meshack's remains were returned home on Thursday April 9. He went into exile in 1982. He was only 21 years old.

Meshack was born on January 8, 1961 in Vaalhoek, Pilgrim's Rest. His family moved to Penge when he was a young boy. He was a staunch member of the ANC.

Meshack received military training in Angola and Swaziland as a member of Umkhonto we Sizwe (MK).

He was one of five Umkhonto we Sizwe members who were killed in an ambush by members of the South African security forces near Alldays in Limpopo on August 3, 1988.

He was shot dead along with Messrs Sechaba Lesimola, Sizakele Buzo, Fuzile Patrick Zigoxo and Thamsanqa Poto.

All five were buried as unidentified paupers at Tshikota Cemetery in Makhado.

A frail Ms Merriam Nyathi, Meshack's mother, said that her family could finally have peace after burying their son. "We only found out in 1995 about his fate and now we can finally bury his remains."

The minister of justice and correctional

services, Adv Michael Masutha, said that today's youth could learn a lot from Meshack about commitment. "He showed true commitment to the struggle for our freedom and that's something the youth can learn from him."

Masutha said that the sombre occasion reminded everyone of the adversity that the people of the past had to face during the struggle for political freedom and more importantly, gave people resilience as they now sought to consolidate socio-economic freedom for the people. He said the process was meant to bring closure to the families which had lost their loved ones during the liberation struggle.

Limpopo premier, Mr Stan Mathabatha, said that it was important that Meshack's legacy lived on. "We have spoken with the provincial ANC leadership that Meshack's name must live on. We will name the local Penge Hospital and road after him," said Mathabatha. His remains were recovered by the Missing Persons Task Team and were identified through DNA testing.

The official handover was done by Masutha. Other dignitaries who attended the funeral included the deputy minister of defence and military veterans Mr Kebby Maphatsoe, Limpopo MEC of health, Mr Ishmael Kgetjepe, ANC Sekhukhune region secretary, Mr Jerry Maseko, Greater Tubatse Municipality (GTM) mayor, Cllr Ralepane Mamekoa and Sekhukhune District Municipality (SDM) mayor, Cllr David Magabe.

# Relatives question cause of death

SKHILA - The death of an elderly man has left his family with unanswered questions. The body of Mr Elvis Mkhonto was found in a pathway in the early hours of Thursday April 9.

Ms Shirly Ngobeni, his niece, said that one of the residents told her that they had seen a corpse and thought it could be her relative. "When I got there and I realised that it was really him, my heart couldn't handle the thought of what could have happened to him," she said. According to Ngobeni, the police said that he had died of natural causes but she did not believe it.

"The are rumours going around that my uncle was heard screaming in the middle of the night. I think people tried to rob him and at the end they killed him," she said.

According to Ms Sarah Ngobeni, a relative who lived on the same yard with Mkhonto, she last saw him on Wednesday. "I got a little worried when I didn't hear him come home because he would normally come home with his friends late at night," she said. Ngobeni was informed by Mkhonto's friend's child that they had found

him laying in the path.

"On my way I kept hoping it's not true and when I saw his body lying there I realised that he is gone," she explained.

"My uncle will be laid to rest on Saturday April 18 in Skhila," said Ngobeni.

# Power line poses a real danger

GA MAROGA - Members of the Chilwane family say they live in fear as an Eskom power cable has been laid in their yard. The cable has already electrocuted two kids, and the rest of the family members are thankful to be alive.

They told *Steelburger/Lydenburg News* that they had previously reported the matter to the Eskom offices in Burgersfort, but no one bothered to come and remedy the situation.

"The last time I visited them, they told me to buy a pole to balance the cable. I am not working and I cannot afford one. It's their responsibility, not mine," said homeowner Kaizer Chilwane.

According to him, they have been living

with the cable in their yard for the past eight years.

The paper visited the family to view the supposed power line in question. It passes along the Chilwanes' vegetable garden and is about 1,70 metres long. Another resident said he was also concerned about the hazards the power line could have on a metal plate in his foot.

Kaizer said he could not be home at all times to prevent the children from playing next to the lines. "I don't know what to do now. I am not sure if I have to take the legal route or what. My family is at risk here, I heard the lines gives kids leukaemia. I just don't know if it will affect my kids."

The paper contacted Eskom, where an agent advised the family to report the matter again at the nearest branch.

#### 1 Introduction

Digby Wells Environmental (Digby Wells) has been requested by De Groote Boom Minerals (Pty) Ltd (DGB), to compile and submit an Environmental Management Plan (EMP) for a Mining Permit Application (MPA), in terms of the Mineral and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002) (MPRDA) to the Limpopo Department of Mineral Resources (DMR).

The MPA has been accepted by the DMR under Reference LP 10656 MR and DGB has been instructed to prepare an EMP, which will include various specialist investigations, and a Public Participation Process (PPP) will be undertaken. One part (Section c on page 1) of the directive from DMR, dated 25 February 2015 relates to consultation with the Land Claims Commissioner and the Department of Rural Development and Land Reform.

# 2 Project Background and Description

DGB currently holds an approved Prospecting Right valid for three years (with the right to take a Bulk Sample) and it now proposes to mine primarily Cobalt and also associated Platinum Group Metals (PGMs) covering an extent of not more than 5 ha on the Remaining Extent and Portion 2 of the farm De Grooteboom 373 KT. Mining will be undertaken by open cut methods and the ore will be transported to a portable plant for crushing and screening. The ore will be stockpiled until transported off site by truck. The mining permit area is adjacent to the Bulk Sample area.

The project entails a construction phase, sampling phase and possibly a decommissioning phase. The decommissioning phase will only be applicable if the project does not prove to be viable.

# 3 Preliminary Consultation

The directive from DMR stated that consultation be undertaken with Department of Land Affairs, if the affected land is state-owned, or the office of Commission of Land Rights, if the affected land is subject to land restitution (refer to Appendix A).

To identify landownership Windeed searches were completed for the affected properties for the MPA and results showed that no properties are owned by the Department of Land Affairs. Properties are held by private owners. As such, consultation was to be conducted with the office of the Commission of Land Rights in order to determine if the affected properties are subject to land restitution.

The Digby Wells Stakeholder Engagement office engaged, by means of telephone and email, with representatives from the Department of Rural Development and Land Reform as stipulated below on Wednesday, 18 March 2015 and Tuesday, 24 March 2015:

- Mrs Gladys Kekana;
- Mr Maphoto; and
- Mrs Linah Bopape.



The Department of Rural Development and Land Reform project manager for the enquiry is Mrs Senwana Makhanana and be reached on (015) 287 2600.

The purpose of these engagements was to firstly ensure that the relevant representatives from the Department Rural Development and Land Reform are consulted and secondly to determine if the affected properties are subject to land restitution. A formal enquiry for directly affected and adjacent properties was submitted on Wednesday, 18 March 2015 (refer to Appendix B).

Feedback was received from the Office of the Regional Land Claims Commissioner: Limpopo on Monday, 23 March 2015 (refer to Appendix B). Results from the feedback indicate the following:

- Farms De Grooteboom 373, Dwars Rivier 372, Frischgewaagd 359, Tweefontein 360 and Thorncliff are subject to restitution land claims by the Masha Community and Moletsi Dwars Rivier Community; and
- Farms Zwakwater 377 and Rieftontein 375 indicated that no information relating to restitution land claims existed.

The Department Rural Development and Land Reform indicated that research about the restitution land claims is ongoing and that relevant correspondence would be provided should claims be identified that satisfies requirements of the Restitution of Land Rights Act (Act no 22 of 1994).

# 4 Next Steps

As part of the MPA the proposed project will be announced early in April 2015 by means of a Background Information Document, placement of site notices and advert and formal announcement letter. All Interested and Affected Parties (I&APs) will be included as part of the announcement; this involves the Department Rural Development and Land Reform. Specific effort will be made, by means of telephonic consultations and where necessary, individual meetings to obtain comments from I&APs, which will be included into a Comment and Response Report and a Consultation Report will be compiled to detail all PPP activities. The Consultation Report will be submitted to the DMR early in May 21015.



The company applied for a mining permit which will allow for the mining of primarily Chrome and associated Platinum Group Metals (PGMs) covering an extent of not more than 5 ha on the Remaining Extent and Portion 1 of the farm De Grooteboom 373 KT.

It is possible that after completing work under the mining permit, De Groote Boom will commence with full scale mining of Chrome and PGMs in terms of a mining right that would be applied for at that stage. Mining under the mining permit will be undertaken by open cut methods and the ore may be transported to a mobile plant for crushing and screening. The ore will be stockpiled until transported off site by truck. The mining permit area is adjacent to the Bulk Sample area and the operational and related infrastructure areas.

The environmental authorisation for the proposed project will require the compilation and submission of a Mining Permit Application and Environmental Management Plan (EMP) in terms of the Mineral and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002) to the Limpopo Department of Mineral Resources (DMR).




