 (DFFE) will be the competent authority for this application.
- **SD** stated that if the communities (or any other water users) will be supplied with water from this pipeline, proof of this will need to be provided to DFFE in writing.
- SvR will confirm with Lebalelo who the end water users will be. If the communities are supplied with
 water from this pipeline, the application will continue with DFFE, if it is only the mines, SvR will
 contact the DMRE for a pre-application meeting.

Listing Notice 1 Activity 9:

- This listed activity will only apply to the first section of the proposed pipeline route (Spitskop pump station to Dwarsrivier pump station) as the diameter of the pipe is 0.5m
- The second portion of the pipeline route (Dwarsrivier pump station to Mototolo Mine) has a diameter of 0.3/0.35m so this listed activity will not be triggered.
- FG wants to confirm if the application will only be for the first portion of the pipeline.
- SvR confirmed that for this listing notice and activity only the first portion will be included. However
 the second part of the pipeline crosses a watercourses at several points along the pipeline, which
 triggers listed activities.

Listing Notice 3 Activity 2

- SvR wants to confirm if the two new proposed concrete reservoirs will trigger this activity as the
 definition of a reservoir was not found in the terminology of the Environmental Impact Assessment
 (EIA) Regulations.
- FG advised to rather include the activity in the application.

Listing Notice 3 Activity 12

- FG suggested the definition of indigenous vegetation be confirmed as there is a timeframe of 10 years after an area has been cleared that it is no longer considered indigenous vegetation.
- If this area has been cleared within the last 10 years this activity will no longer be triggered.

<u>Listed activities - general</u>

- FG stated that non-linear infrastructure such as pump stations and construction camps must also be considered when assessing the listed activities triggered. Consideration of exclusion for linear activities must be taken.
- If the applicant is not the landowner ensure that consent is provided for the non-linear aspects, and needs to be included in the application form.
- FG stated that if the application is processed by DFFE the areas that are within the specific geographic areas that triggers Listing Notice 3 activities need to be identified in the application form.

Specialist Studies

- SD stated that the Department can not provide the exact specialist studies that are needed.
- SD stated that the screening tool will provide AVDE with the exact specialist studies needed. Based on that if AVDE need to commission specialist studies, or motivative why they are not required.

Way Forward

- SvR will confirm with Lebalelo who the end water users for the pipeline will be.
- SyR will confirm who the competent authority for this project will be.
- SvR wanted to confirm that a Public Participation Plan (PPP) must be submitted to DFFE if they are
 the competent authority.
- FG confirmed that the PPP will be submitted to her for approval.
- FG stated that the screening tool identifies protocols that specialists need to consider for their reports.




Figure 1: Current and proposed LWUA pipelines

4. Project description

The LWUA was established to supply raw water to mines along the Eastern Limb of the Bushveld Igneous Complex. The main aim of the LWUA is to supply raw water to a number of existing and planned new mines in the area, and as a spin-off, to provide additional capacity in the water supply scheme to meet the requirements of the rural population in the area. Only raw water is provided by LWUA, and the responsibility of treatment to drinking water standards lies with the Water Services Authority (WSA).

The users receiving the water from the pipeline make up the LWUA. The Lebalelo water supply forms part of the Olifants River Water Resource Development Project (ORWRDP). Currently water is sourced from the Olifants River via the Flag Boshielo Dam and abstracted at the Havercroft weir. Water will in future be obtained from the Steelpoort River via De Hoop Dam for the Southern Extension 2 pipeline .

LWUA has the following authorisations for the existing pipeline (SE1):

• A weir near Havercroft mine and a 46km underground pipeline. All infrastructure such as pump stations and reservoirs are included in this development. File No. 16/1/3/2-23, issued on 26 February 2001 by the MEC for Agriculture and Environment; and

• Southern extension of Lebalelo Water Supply Scheme Project, Ref No. 12/12/20/531, issued on 14/03/2006 by the Department of Environmental Affairs and Tourism.



5. Legislative requirements

The environmental related authorisations required for the proposed SE2 Pipeline Project are as follows:

- A Basic Assessment process in terms of the National Environmental Management Act (Act 107 of 1998) (NEMA) and the Environmental Impact Assessment (EIA) Regulations. The competent authority for this process is the Department of Forestry, Fisheries and the Environment (DFFE);
- A Water Use Licence Application (WULA) in terms of the National Water Act (Act 36 of 1998) (NWA). The competent authority for this process is the Department of Water and Sanitation (DWS).




Figure 3: Basic Assessment and Water Use Licence Processes

The environmental related authorisation processes are running concurrently and require the involvement of stakeholders. Therefore, a single integrated stakeholder engagement process will be undertaken in compliance with all legislation. The environmental related authorisation processes are illustrated in Figure 3.

During the Basic Assessment process, phase, potential impacts are identified, and management measures are proposed to mitigate negative impacts and enhance positive impacts. A Basic Assessment Report will be compiled and made available for public comment for a period of 30 days. Once the public comment period is concluded, the Basic Assessment Report will be updated with the comments received from stakeholders and will be submitted to DFFE for decision making.
