CETA ON Track to Meet Construction Skills Needs

The Construction Education and Training Authority (CETA) was under administration from 25 March 2011 to 31 March 2013. Between 1 April 2013 and 29 July 2013, the CETA operated under its CEO at both the operational and governance levels. From 30 July 2013, the CETA has had a substantive Board as its Accounting Authority.

During the period of administration, the Administrator focused on eliminating major risks faced by the organisation, including the reduction of the organisation's exposure to general risk and financial losses. The period of administration also focused on sound management and governance systems for the organisation. This resulted in the appointment of a CEO and the establishment, and subsequent appointment, of the Board of the CETA by the Minister of Higher Education and Training.

Building on the achievements and successes of administration, as well as the subsequent work of management and governance, the CETA is on track to meet the targets it must achieve to address construction skills development needs and meet its obligations as set out in its agreement with the Minister of Higher Education and Training.

Accordingly, the CETA is pleased to release the information below, in the public interest, to illustrate – factually – the progress it has thus far registered in its contribution to the country's Skills Revolution. The information is also released as an attestation to Government's successful stewardship of skills development and the amelioration of the plight of thousands of young people who would ordinarily be outside the economic pot of our country.

The forensic audit resulted in a total savings of R314 230 000.00 to date – monies which would have been paid irregularly, some to fraudsters in the system. All the learners that have been affected by the cancellations of projects as a result of the forensic audit have been given the assurance and opportunity to complete their training. To date one hundred and twenty four (124) learners who started with their apprenticeship training will complete it and be certificated in two months






UPINGTON SOLAR PARK Locality Map




