Mr Ken Goelst	Keus Trust	How will the power supply to Mokopane town be affected in terms of load shedding?	<p>During the construction phase the 5MVA rural power line from the Mokopane substation will be used for power supply. It will be used for approximately 2 years until the proposed 75 MVA power line from the Medupi power station has been constructed.</p> <p>During the operational phase the 75MVA dedicated power line from the Medupi power station will be used to supply power to the mine. The proposed mine will therefore have no impact on the local power usage.</p>
Mr Ken Goelst	Keus Trust	How will the community be affected by blasting activities?	The proposed Platreef mine will be an underground mine at a depth of 800 – 1 000m. Blasting could have an impact during the sinking of the shaft up to a depth of 150m. After that, blasting will not be felt or have an impact on the surface infrastructure.

Mr Ken Goelst	Keus Trust	How will the water table be affected by the mining activities?	The mine shaft will be sealed off from underground water so the mining activities should have no impact on underground water.

The trend is looking good for the 2 years of monitoring data collected. The shaft will be grouted to stop water flowing into the mine. 


