## INVITATION TO COMMENT

**APPLICANT:** Oliphants Housing Estate (Pty) Ltd

**PROPOSED ACTIVITIES:** Oliphants Housing Estate (Pty) Ltd is proposing the **construction of a mixed-use residential development** on the Remainder of Portion 18 of the Farm Roode Pan 70 in Kimberley in the Sol Plaatjie Local Municipality, Northern Cape Province. The property lies approximately 10km to the north of Kimberley between the Kamfers Dam and the Midlands Road, the total study area proposed for development is approximately 150 hectares

**LEGISLATION:** In terms of sections 24(2) and 24D of the National Environmental Management Act (No. 107 of 1998), as read with the 2014 Environmental Impact Assessment (EIA) Regulations of Government Notices GNR 326, 327, 325 & 324 (as amended), the proposed development requires a Full Scoping and EIA due to Activity 15 of the Listed Notice 2 of the 2014 EIA Regulations, and authorisation is required from the National Department of Forestry, Fisheries and Environment (DFFE). In terms of Section 21 of the National Water Act (Act No. 36 of 1998), a Water Use License is required as a result of the project' proximity to watercourses.

**Enviroolution Consulting (Pty) Ltd** has been appointed as the Independent Environmental Assessment Practitioners to conduct the Basic Assessment, Water Use License Application and Public Participation Processes (PPP) for the proposed development.

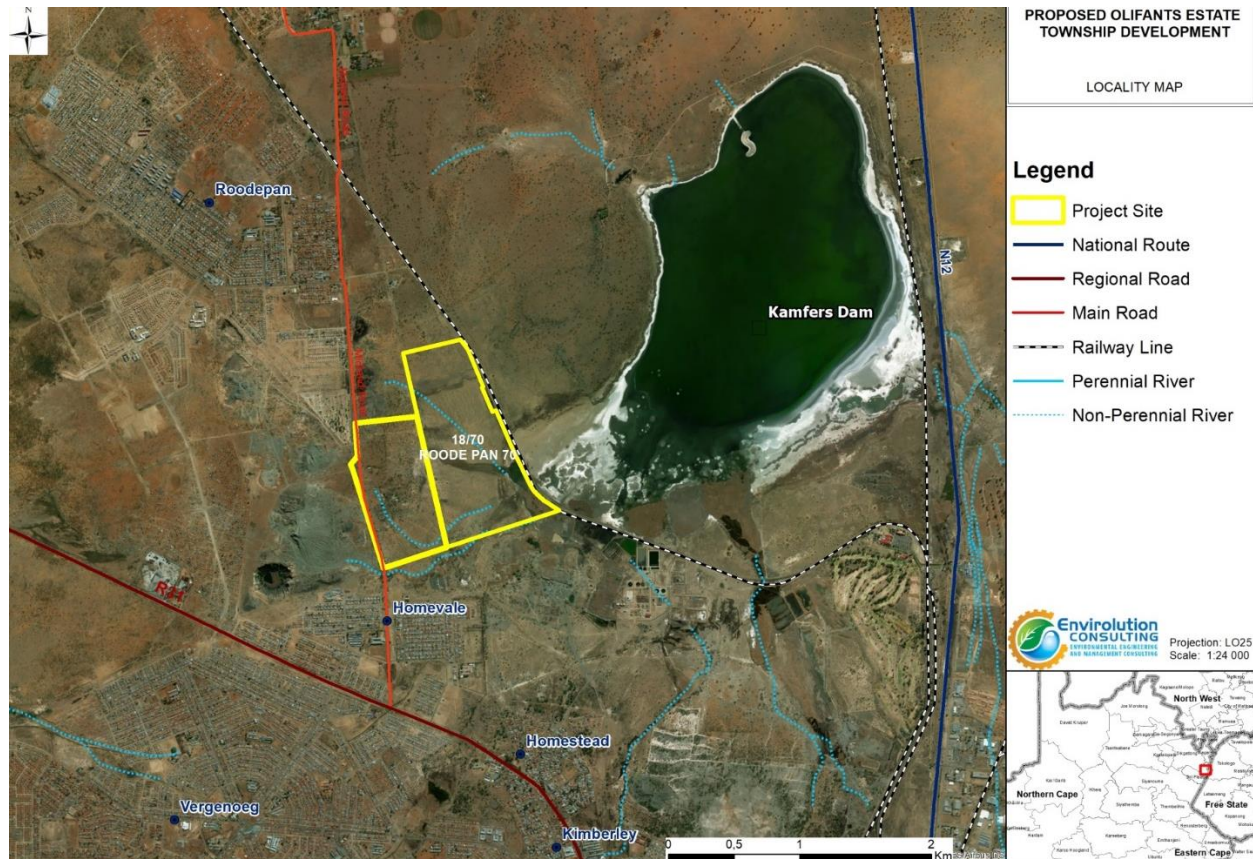
